Standing Orders – extended past 15 minutes.

- 1. PA Why Chris Lambert, majority of the residents are apposing application, why been delayed?
- 2. Why has hedge been removed at development should have been netted from bird nesting season.
- 3. Buses stopping nothing been planned,
- 4. Personal experience of supported living not opposed to it, mum whose son lives in those circumstances. Way worded, MOP felt everyone has disability.
- 5. Application underhandedly, other some res received letter, highways dept said parking on site is "substantial" not the case. Queried behaviours fear that this is a specialise behaviour and res fear for repercussions. App in wrong area. Issue with noise pollution, try and reduce noise. Highways in one day 6 people coming in and out, not accounted for schools/medics etc/visitors or families. Also inconsistent 3 on proposal, design and access statement 5 people. No social benefit to area impact on elderly. App has been dealt with appropriately haven't got access to web. Issue with parking esp worse with school.
- 6. Walls not sound-proof, with noise. Area largely elderly. Placed in wrong place semi detached house in predominately elderly area.
- 7. Expanded property garden not appropriate size. Internet not suitable. Facilities not suitable up to 18 no docs or chemist in Stanton under Bardon.
- 8. Money making scheme by developers who have bought property.
- 9. MOP two near accidents on rear, sharp bend very dangerous.
- 10. Elderly people have mobility issues, scooters on pavements, Dangerous for pedestrians, Not ample parking where are they going to sit out no space, no room for basketball, outside noise/inside noise is problem, no evidence for sound.
- 11. Kids will need to share bathrooms,
- 12. Economical incentive only from developer.
- 13. Some people can't attend due to mobility issues, small minority of res.
- 14. Increased traffic difficult on road, esp. main street.
- 15. Should stay residential house no way 5 cars can fit on drive.
- 16. Rat problem Everard way. Asked to contact clerk.
- 17. Look after housebound man. Turn out bored and terrorise people.
- 18. No facilities for these children to do anything in Stanton under Bardon + nothing for them in house only outside space.
- 19. Could be adults with mental problems.

• Updates from Borough Councillors Clare Harris and Chris Lambert

Website / FB / Email.

Chris – Now understands the feeling of res. His personal experience is that very little ASB. Not hear to defend decision – planning law planning considerations. Closing date is 9th. Decision date – 28th May. If they refuse, that's it. If approved, or recommend, due to number of objections, planning committee – meeting in mid-June. Make people aware – opportunity for public speaking, neither or on committee – members that are on committee – decision made by planning committee. If refused, applicant can appeal to planning inspector – opens up new process and not seeing many appeals get refused. Process will take another 2-3 months.

Claire – difficulty – any work is like any other work is OK, in order to objection with sound planning objections – parking, disruption, niche to find what we can use as planning matters – one is DM10 for eg. Case work – seen a high volune of carehomes – not really being considered – major concern is safeguarding of children – some not even inspected by Ofsted, many not registered, Most aren't local – 80% sent from London. Not regulated, no whilsteblowing, not sure if children are being properly looked after.

Bus – 125 – hasn't been terminated, still operating no disruption – routes are not being cancelled – replaced. No loss of provision but improvements likely.

Chris – quiet due to election. Has annual council meeting – clashes with Annual Village Meeting.
