22/31 To consider the replacement of the missing fingerpost in the parish. It was resolved to purchase a replacement fingerpost.

22/3J To reconsider the decision made in February 2022 to donate £100 to Bridgwater Citizens Advice Bureau.

The Clerk has made several efforts to contact the Citizens Advice Bureau, which is now called Sedgemoor not Bridgwater, with no success. A letter was returned undelivered, and three calls to the switchboard asking for the manager to contact the Clerk were not responded to.

It was resolved to reverse the previously decision to make the donation of £100.

22/3K To consider a response to the reply received from Sedgemoor District Council on 17th February to the letter sent to them on 14th February regarding regarding Local Plan Policy C5.

A draft response by Councillor Rolfe had been previously circulated to Councillors.

It was resolved to submit the response.

22/3L To receive an update regarding the footpath between Cross and Axbridge. Negotiations are continuing with the two landowners.

22/3M To consider whether the Parish Council should offer financial support to voluntary organisations in the parish to enable them to hire the Memorial Hall.

It was resolved not to offer financial support to voluntary organisations at the present time.

22/3N To receive and consider a Highways Report.

Councillor McCarthy gave the report.

Sedgemoor District Council have been asked to replace two stiles in the parish which are at the end of their natural life with galvanised ones. The permission of the landowners will be required, so the SDC officer has been asked to action this.

Community Speed Watch - A date has now been arranged for PCSO Stephen Hemmett to meet and discuss training with potential volunteers for Community Speed Watch (the meeting is booked and will be held at the village hall)

Potholes - work completed.

The potholes in Church Lane (Thatcher's entrance gate) and in Kennel Lane (near the notice board) have now been repaired. Most of the potholes in the Webbington Road pull in have been filled in.

Trees from Sedgemoor District Council - The Silver Birch and Cherry Trees have now been planted. They sit in a corner of the grassed area of the Webbington Road vehicle pull in area.

Road Markings

A parishioner has reported that she was nearly hit by a car at the junction of Old Coach Road and Webbington Road (near the corner of village hall). The parishioner would like the Parish Council to contact SCC highways about the faint hatchings at each side of the junction.

Matters arising from Coffin Lane Meeting

Amended countryside code:

Guidance to landowners in the new code in respect of any gates allowing access to all including those using mobility scooters and buggies. In addition, the requirements in respect of fencing etc. It was agreed that the Coffin Lane Campaign Group would write to the Somerset County Council footpath officers requesting he bring these matters to the attention of the landowners as the current guidance was not being followed.

Matters arising from the Cross, Compton Bishop Climate Action group meeting

I have emailed the Somerset County Council Climate Emergency Team (on behalf of the Cross, Compton Bishop Climate Action group) with regards to the verges in this parish and the possibility of using parts of verges for community planting.

- 22/3P To consider the purchase of thirty pounds worth of petrol for the cutting of the grass verge at Kennel Lane.
