21/10I To consider the anti-social behaviour on the Webbington Road.
The Council noted there is a continuance of speeding cars and noise. The clerk will provide the police with the video footage from the speeding vehicles on the A38 and the report on the roads in the parish that was previously sent to Somerset County Council. The Police will be asked how they are monitoring the area.

21/10J To consider the enhancement of the Springfield Wildlife Site.
It was agreed that the clerk would liaise with Land Forest regarding a visit to the site and Councillor Parker will research options and liaise with S Ayling regarding options to present to Sedgemoor District Council.

- 21/10L To consider the creation of a speedwatch group in the village.
It was agreed that there will be a final attempt to recruit volunteers when the Parish Council and Memorial Hall send out a letter asking for members of the parish to support the Council and Committee.
- 21/10M To consider adding large stones to the Webbington Road layby.
It was resolved that the Council would not add large stones to the Webbington Road layby.
- 21/10N To consider Progress on Representations to Somerset County Council regarding main highway issues and their impact to vulnerable users.
The Council will follow up with County Councillor B Filmer for an update and with Somerset County Council in November if no response has been received by the next Parish Council meeting.
- 21/10O To consider asking the landowner to cut the overgrown hedge on the footpath from Cross to Axbridge.
This item was removed from the agenda.
- 21/10P To consider asking Somerset County Council to add an additional bus stop to the 48-bus service in Cheddar.
It was agreed that the clerk would ask Somerset County Council to add a further stop at the Market Cross or outside Kings of Wessex School as the Tweentown bus stop is a long walk with shopping from the supermarkets.
- 21/10Q To consider a response to Somerset County Council regarding the lighting issues on the A38 junction.
It was agreed to postpone this until further notice.
- 21/10R Councillor reports
Councillor Rolfe advised that Sedgemoor District Council will be pollarding the trees at the Springfield Wildlife area over the next 6-8 weeks and cutting the hedges. More nesting boxes are required on the site.

Councillor Parker advised that a paddock in the village and a small musical group had been secured for the Jubilee celebrations next year.
