25/06l Safe Pathway Campaign Cross Lane – update on any progress the Landowners.

The Clerk confirmed that he has received a positive response from the local MP – Tessa Munt who has agreed to meet the council to help move the project forward with the Landowners. It was agreed that the Clerk to organise a meeting with the MP in August to include representation from Axbridge Town Council, Somerset Council and other interested local community groups such as the Safe Pathway Campaign Group. In the first instance the Clerk will obtain dates of availability from Tessa Munt.

25/06J To consider Councillor Training.

Appropriate training sessions to be considered when a fresh set of courses become available.

25/06K To receive Councillor reports.

1)Vegetation covering road signs and public benches — Councillors McCarthy and Dean mentioned that some road signs are not visible and a bench in Church Lane cannot be used due to overgrown vegetation. This appears to be the resident's responsibility letting such growth over their boundaries and not being sufficiently aware of the problem. It was agreed that, wherever possible a "quiet" word with the resident would suffice, otherwise an official letter from the Clerk may be needed. In the meantime, the Clerk will get the situation clarified with Somerset Highways.

Update on cutting back of vegetation that is stopping the water flowing through streams that cause problems with overflowing water and no good for the wildlife habitat.

The Clerk confirmed that he has not had any response from the Landowner who still needs to cut back the vegetation, even though a further letter was sent to the Landowner after the last meeting. It is understood that he is in contact with the Environment Agency on how to proceed with this issue.

25/06M To consider issues encountered with the National Trust (NT).

Councillor McCarthy confirmed that some of the issues raised with the NT has now been resolved. Problems regarding potholes still need to be completed. NT did indicate that they are bringing in stone for another project and if there is any surplus, they will use it to fill in the potholes in the parking pull-ins near the NT signage and the Rackley Lane junction. There will be an update at the next meeting.

25/06N Update of the fitting on the back of the village sign in Old Coach Road (towards Weare).

After the last meeting the Clerk arranged for the signage to be fitted as soon as possible. He will contact Arien Signs for an update. Hence the reason why the payment has not been made under 25/06F.

25/060 To consider appointing a Local Footpath Liaison Officer.

Councillor Parker confirmed that a local resident has agreed to take on the role as the Local Footpath Liaison Officer. The current officer (who wishes to retire from the role) will update the new officer on the procedures.

25/06P Update on the Anonymous letter of complaint regarding Yeo Bridge Farm (off the A38 at Lower Weare) which has been forwarded to Somerset Planning Enforcement and the Environment Agency.

Although both Somerset Enforcement and the Environment Agency had acknowledged the letter there has been no further response from either agency as to whether they would act on such an anonymous complaint. It was resolved that the Councillors would investigate the situation themselves and report back to the Clerk who will then, if necessary, contact both agencies under the auspices of the parish council.

25/06Q To consider a request for a donation towards the annual grass cutting charges at St Andrews. It was resolved to increase the donation to £700 (£500 in the previous year) towards the grass cutting for the 2024 season to help cover the shortfall for the year. The Clerk to advise the Churchwarden accordingly and explain that this increase is a "one off" for the 2024 season only. With all the changes being made at Somerset Council and the handing down of certain responsibilities to local council's further donations cannot be guaranteed.
