2. Declarations of interest in items on the agenda. : No declarations declared

3. Confirmation of minutes from previous meeting - Resolved - Minutes December 2024 Monthly meeting confirmed and signed.

4. Public Participation: Mr D Maddocks.

David Maddocks

- a) Discussing the recent meeting held by Hood Hall, expressed concerns regarding the location of Devauden Music Festival, (not being in Devauden) and number of days, (1 or 2 day) event.
- b) Raised concerns over blocked drains and gullies within the locality, including (but not exclusive) Star Pitch, Forest Track by Hood Hall, and Well Lane Drain (which he attempted to clear himself). Cllrs confirmed that it would be wise to keep reporting on Mon APP, and DM to share additional locations so **Clerk** can also report.

Cllrs thanked Mr Maddocks for his comments and confirmed DCC has no involvement in the festival.

5. Police Report – The Police report was shared and taken as read. **Clerk** to affirm a definite date with E Park.

There was **one log** around DEVAUDEN from 01/12/24 – 31/12/24, this involves different types of incidents. These were dealt with by NPT and Response officers from the Monmouthshire south area.

There are two incidents, we cannot disclose with the community council as they are too personal to discuss.

1) There was a report about speeding in the area, this has been dealt by NPT who have been doing speed monitoring around the area during the Xmas period.

What we plan to do in January:

- · Active patrols the area.
- · Still conduct speed monitoring in the village.
- · Attend the next council meeting (If possible).

6. Matters Arising

- i. **Play Equipment** Cllr J Williams was pleased to confirm that the local group have been granted a lottery grant of £55k towards the play area (STC) This with the donation of £25k from Hood hall puts them closer to the full amount, which should be finalised soon.
- ii. Community Orchard: Cllrs expressed their concerns regarding lack of progress, and Clerk to chase with Cllr Buckler. Discussed Section 106 and how this can be escalated.
- iii. Land at Allotments update Awaiting the documents to sign
- iv. Meetings attended & (forthcoming meetings):
 - i) Several Cllrs attended the meeting held by Hood Hall discussing the new set up with trustees. It was well attended by local residents.

- ii) 3 Cllrs attended the Code of Conduct Training, It was well received and informative. **2 more Cllrs to attend** later this year and clerk (if required).
- iii) Meeting with Mr H Dibble (see item 6 viii).
- v. **Noticeboard at Llanfihangel Tory & Mynydd –** Quotes were discussed, and it was confirmed that the Clerk will purchase from Greenbank's. Clerk to confirm insurance arrangements with Llanfihangel community group. Group have also requested first aid training. **Clerk** to enquire on courses available.
- vi. AGM Date Clerk confirmed that the AGM will be held in Itton Hall on Tuesday 25th May 25
- vii. Website Nearly ready to launch, Cllrs and Clerk to finalise areas on website.
- viii. **Meeting with Itton Landowner.** Cllr Kitson and the clerk met with the landowner who walked the area and explained the issues, it was concerning to hear that the landowners stock fence had been cut (apparently for dogs, but sheep could go the other way) and damage to the gate. Also other field gates left open during last year by "ramblers" not on footpaths, resulting in stock in the wrong fields and in some cases, shut in without access to water. There are some genuine concerns from the Landowner who was trying his best to be accommodating. Cllr Kitson produced a detailed report, showing possible solutions. This was shared at the meeting and also with Landowner. **Awaiting feedback landowner.**
- ix. Devauden Tree Cllrs discussed the tree and funding; additional funding is required to progress with the sculpture. It was noted that now the hedge is cut, the tree is a very prominent feature for the area. Current funding DCC £2k, Private offer of donation £1k & £1k, plus match funding of additional £1k, local contributors/business sought. Clerk to look at funding source
- **x. Itton Telephone Box** awaiting quote for new door.
