- 4. Public Participation: Mr D Maddocks
 - i) Mr Maddocks raised concerns regarding hedgerow, on the Tintern to The Cot Road opposite the fish pond by the bridge.
 - ii) Hedgerow in Wolvesnewton, near Well Lane / Great House Farm, needs siding

Clerk to action report on Mon, and DCC reminded Mr Maddocks that he can also report to MCC online using the same service.

- **5. Police Report -** Police report was not received Clerk to chase
 - i. Play Equipment Cllr J Williams reported from the Playgroup Action Group, that the cost increase was 170, and that there is expected to be a small shortfall. A fit date beginning of June is planned. The group are still fundraising and applying for grants for the cost to install fencing around the play area. No Action
 - ii. Community Orchard: Cllr Buckler confirmed that MCC planning had contacted the Management company regarding the Community Orchard and requested the fencing be removed, to enable the village community to enjoy the gifted space. No Action Monitor
 - iii. **Meeting with Itton Landowner.** Landowner confirmed that members of the public had damaged padlocked gate on the permitted path, this damage creates difficulty in creating a work around for walkers. **Cllr Kitson Smith to contact and discuss.**

 - v. **Land at Allotments: Resolved –** No action required for the land prior to purchase. **Clerk** to notify Solicitors.
 - vi. **Meetings attended & (forthcoming meetings):** Cllr A Williams confirmed he had attended a walk around meeting with MCC, looking at a shopping list of items needed and awaiting minutes of this meeting.
 - vii. Noticeboard at Llanfihangel Tory & Mynydd Noticeboard has been delivered. Awaiting confirmation its been checked. Clerk to add to asset register and insure.
 - viii. **Website** Nearly ready to launch, Cllrs Williams, H Turner and Clerk to meet to finalise and go live.

Clir H Turner – Coal Lane update, visited MCC with Rachel Buckler and pointed out that the road - listed as a restricted byway but had been changed to unclassified road, which means motorcycles are now using it (and being advertised to motorcyclists as such). MCC acknowledged the error and said they would investigate. The published status is not legally correct and so needs to be rectified.

Jane Lucas - Still awaiting dead end signs on Church Lane,

Cllr P Kenington - Met up with residents and Gareth Freeman and junction to Y Feddw, Road needs clearing and white lines put in to make pulling out safer. **Action MCC May/June Cllr A Kitson Smith** – Absent.

Cllr J Williams: – As discussed previously Coal Lane issues with motorbikes reported on the lane and trees belonging to Natural Resource Wales in need to cutting back. **Clerk** to chase NRW dn report bikes to MCC.

Cllr A Williams: - No new issues to report.

Clir M Powell: Concerned about Defibrillator not working, concerned about state of phone box, **Clerk** to make sign and put in telephone box, and ensure 999 are aware its out of order. **Clir Powell to seek additional quote to repair door**.
