7 OVW - Cllr J Williams and Cllr Powell attended meeting in April. A representative from Warm Wales and Catherine Fookes MP were speakers at the meeting. Contents of their presentations will be circulated to councillors when OVW produce the minutes.

8 Website. Cllr A Williams and Cllr Turner talked us through the website and invited comments on how it should be amended. Some suggestions were given on what else should be included. Cllr H Turner – attended a meeting in the village on Wednesday 9 April 2025 with Catherine Fookes to discuss road safety issue in the village. Cllrs J Williams and R Buckler attended along with a local resident. It is disappointing the report published by the MP's office did not mention the attendance of DCC or MCC representatives at that meeting. Has items to be raised with Cllr Buckler which will be bought to the next meeting.

Cllr P Kenington – will be attending a MCC planning course.

Cllr A Williams – Reported on the new bilingual signs that will be placed in Itton.

Cllr M Powell - Has placed a sign on the Itton telephone box informing the public that the defibrillator is not working. Has been asked when the removed defibrillator in Howick will be replaced. It will be discussed at our next budget meeting. A resident has questioned why DCC is spending money on the pollarded tree in Devauden. It was reiterated that a donation has been promised towards the cost of a tree sculpture and voluntary donations are being requested. He had attended a meeting in the village with Cllr Buckler and local residents regarding road safety and speeding.

Cllrl Lucas - The expiry date on the pads on the recently installed defibrillator in Newchurch is in 12 months' time. The specification with machine says the pads would last for 3-5 years. Clerk to be asked to contact the supplier and request ' fresh pads' to replace the current ones.

Cllr J Williams - Agreed with Cllr Turner that it was disappointing that our attendance was not included in the report on Catherine Fookes visit to the village in view of our ongoing concern over road safety/speeding in the villages. Has items to be raised with Cllr Buckler that will be carried over to the next meeting. The very best wishes of all the council were sent to our Clerk.
