Update from the previous meeting

B4RN

A village resident advised some more of the houses in the village have now been joined onto the network

Communications

The committee agreed to donate £50.00 to both charities

Roads

Clerk advised she has had no response from Fix My street re the issues with the over hanging bushes from Warshaw bridge to Heron House

The chairman asked the clerk to make an official complaint to the council Nick Morphet advised the clerk to contact David Hunt in neighbourhood services he can then contact the landowner who is responsible for the overhanging bushes and ask them to cut the hedges back

A member of the committee asked if the generator was now fully operational a village hall member advised they were unable to start the generator as they didn't have the operating instructions they had contacted Burncliffe Electricals to obtain a copy

A member of the committee asked if the church would like to contribute to the cost of the Christmas tree a donation is to be made once the carol singing has taken place

A member of the committee advised they would contribute £50.00 to the fuel used by the parish volunteers who cut the grass in the church yard

Following on from the recommendation to replace one of the swing in the playpark the clerk has looked into purchasing a new swing the committee agreed for the purchase to go ahead and a village member offered to install the swing

The committee voted on holding the dog show again the vote was 5 to 1

All proceeds from the dog show will go to Sit Giles church
