

# Minutes of the Garve & District Community Council ordinary meeting held on eptmember 2025 on webcam recording kept for 12 months https://bit.ly/GDCC-Meeting16Sept2025

#### Welcome and Introductions

**Bob** opened the meeting at 7.10pm and welcomed everyone. He also confirmed that this meeting would be recorded as per the agenda and will be archived and available for viewing for twelve months thereafter. Recordings will then be deleted. He reminded members of the public that although our meetings are not public meetings, they were still very welcome to attend Community Council meetings even on webcam and take part in the discussions under his guidance (see section 12 of the Constitution) and that phones should be on silent.

**Declarations of Interest** - the Chairman is a Garve Public Hall Trustee, a Friend of Garve War Memorial, a LCT elected Director and a member of the GD CORe land panel. The Treasurer noted she is a land owner with regards to the SSEN underground cable from the Western Isles to Beauly and Community Council elected The Secretary and Co-Opted Member Simon Friend are members of the Wyvis Natural Playpark group.

Community Council elected members confirmed that they had read all documents due to be discussed tonight before the start of this meeting.

Approval of draft minutes of the ordinary meeting held on Tuesday 19<sup>th</sup> August 2025 via webcam were proposed without amendment by Sadie and seconded by Simon, unanimously agreed. Minutes are available at Garve Post Office and on our website.

# Access Ranger Talk - Richard MacLennan

#### Introduction

• Bob welcomed **Richard MacLennan**, seasonal Access Ranger with Highland Council, to give an overview of his role and issues in the Garve area.

## **Background**

- Richard lives near Fortrose and has a background in small-scale farming.
- Has worked as a seasonal ranger in Mid-Ross and Black Isle (2022-23). No service in 2024 due to lack of funding. Returned in 2025.
- Took a short break mid-2025 after a heart attack; some data gaps during this period.

## Ranger Role

- One of 16 rangers across the Highlands.
- No enforcement powers; role is to:
  - Monitor access and visitor behaviour.
  - Promote the Scottish Outdoor Access Code.
  - Report issues to relevant authorities.
- Works Friday to Sunday:
  - o Fridays cover furthest areas (e.g. Achnasheen, Braemore Junction).
  - Saturdays/Sundays include split patrols (morning and evening).

#### **Visitor Behaviour**

- Most visitors behave responsibly.
- Small minority require advice or can be difficult; rangers trained in conflict avoidance.
- Repeated common excuses for inappropriate camping/parking behaviour.

## **Garve Area Observations**

- **Little Garve:** No major current problems, though graffiti, fire pits and litter noted in past.
- Ben Wyvis: Generally fine.
- Silverbridge-Black Bridge:
  - o Regular fly tipping (builders' waste, tyres) in large layby near Inchbae.
  - o Toileting issues also reported.
- Loch Glascarnoch:

- Popular motorhome stop. Most visitors behave well.
- Problem area at track to loch side: frequent fires despite fire risk. Signs often vandalised or ignored.
- Silverbridge (reserved for later discussion): Specific issue noted to raise separately.

## Achnasheen Road {832} Observations

- Lochluichart Some litter and toileting issues despite bins being available.
- Opposite power station Grudie
  - o Large fire pits regularly built near water's edge.
  - Previous efforts to block vehicle access (moving a large stone) have been undone, with vehicles returning to off-road camping and roof tent use.
  - Achnasheen lots of issues with dirty toileting especially between Midge Bite and the village.
- Traffic incidents:
  - Lay-bys become heavily used during road accidents further west, with vehicles parking overnight while waiting for roads to clear.

#### Loch a'Chuillin Area

- Large drive-in lay-by screened by trees/bushes attracts fly tipping builders' waste, paint, tyres.
- Abuse from fishermen:
  - o Multiple large fire pits often 7-8 visible at any one time.
  - Litter and mess consistently left behind.
  - Rarely catch offenders, but when encountered they have been fishermen who present language barriers when challenged.
- Ongoing misuse includes stockpiles of firewood being brought in for repeat visits.
- Serious road safety concern:
  - o Gateway access to boathouse located on a fast stretch of road.
  - Vehicles parked dangerously on verges; described as "an accident waiting to happen."
- Bob noted the estate had previously petitioned to have the lay-by closed.
- Sadie suggested gathering photographic evidence and publicising the issue online to raise awareness.

## Parking and Lay-bys

**Richard** explained that although some have suggested closing the lay-by, it would not prevent parking problems. He had photographs showing four or five cars parked at the gate, sticking out onto the road. Closing the lay-by would likely just push drivers to park further along the road, forcing them to walk on a fast stretch, which poses safety risks.

**Caroline** added that when the community ran a litter-picking group, this lay-by was always the worst area for rubbish, with frequent fires and fly-tipping. Richard confirmed that fly-tipping remains an ongoing problem, though frustratingly difficult to tackle.

## **Achnasheen Toileting Issues**

Moving on, Richard noted that the Achnasheen public toilets are currently closed. He monitors local reports on social media (though cannot comment officially as a council employee) and was aware of significant toileting problems in the area — particularly around the pond, the train station, and even private gardens.

To mitigate this, he installed signage discouraging toileting and directing people to the nearest facilities, which are 10, 15, or 20 miles away. **Sadie** highlighted concerns raised by a local resident, Sam, who is renovating a property in Achnasheen. Sam had reported people using his garden, the platform, and bushes nearby, forcing him to erect Harris fencing as a deterrent. Richard confirmed he had acted in response.

**Bob** added that Sam even reported coach parties stopping there, including French tourist groups. Richard expressed surprise and dismay at this.

## Abandoned Caravan in Achnasheen

**Richard** reported another issue in Achnasheen: an abandoned caravan. This has been reported by several people and now carries official notices, meaning it should eventually be removed. **Sadie** asked whether the removal process takes 28 days once notice is served. Richard said he was unsure of the timescale for caravans, though his team must give seven days' notice before removing abandoned tents. He hoped the caravan would be cleared soon, noting it had been shifted slightly from the charging points to a nearby parking space opposite the railway platform.

## Silver Bridge Encampment

Attention then turned to Silver Bridge, a popular overnight stop for motorhomes. **Richard** explained that one man has effectively taken up residence there since January. Although presenting himself as part of the travelling community, Richard stressed that he has not actually been travelling, which undermines that claim.

Initially, the man was repairing his broken-down van while living in a wigwam in the woods. His van remains neither MOT'd nor taxed. Although Richard reported this, the only outcome was that the van was declared SORN. The man has since acquired another van, giving the impression he has financial means, yet continues to occupy the site.

Visitors find his presence off-putting, particularly as he parks at the top of the steps leading to the viewing point. Richard noted that there is often a "herbal" smell when his doors are open, and the man appears to be insulating his new van with sheep fleeces. While not leaving waste outside (he uses the toilet facilities on-site and has a log burner indoors), he does contribute to overflowing bins and stores firewood beneath the vehicle.

**Sadie** asked whether he had been served with an official notice to leave and whether the land was council-owned. Richard believed the site belongs to Highland Council Roads Department, but despite repeated contact from his manager, no response had yet been received. He noted that in other areas, similar problems had been resolved swiftly, and could not explain why nothing had been done here.

# **General Ranger Work**

**Richard** outlined his broader duties: his team patrols Friday to Sunday, with Mondays and Tuesdays reserved for report-writing, community engagement, and tidying up problem sites. From late October, ranger numbers will reduce to a quarter, with winter work focusing on path surveys, maintenance, and larger project management rather than patrols. He encouraged members of the community to report issues to the Ranger service online or to Police 101 / 999.

## Fire Concerns and Enforcement

Sadie then raised the issue of fires. Richard said there is strong support among Rangers for

seasonal fire bans, similar to those already enforced in the Loch Lomond & Trossachs and Cairngorms National Parks. However, such policies are set above his level.

**Simon** noted a recent proposal for fines in some areas, which he felt could be a good deterrent. Richard added that Rangers share intelligence on problem visitors via WhatsApp groups to help catch repeat offenders and educate them.

**Sadie** also asked about increased signage, noting Aberdeenshire had found it effective in some trial areas. Richard, however, felt signage often failed because people become "sign-blind" and focus on scenery rather than instructions. He gave the example of Chanonry Point, where multiple "No Motorhomes" signs are routinely ignored.

# Winter Ranger Service and Local Coverage

Richard confirmed that the current ranger contract runs until the end of October. After that, staffing is reduced to a skeleton service over the winter. He explained that last winter he was retained on a casual basis, carrying out a variety of odd jobs across different parts of the Highlands, including work in Ballachulish and other areas. Although scaled back, the service does continue through the off-season.

**Sadie** asked whether there were any outstanding jobs in the Garve and District area that might be picked up during the winter period, such as path maintenance or repairs. Richard said no core path surveys had been carried out locally so far this year, but these are scheduled for the off-season. He added that no issues had been flagged up to him to date.

**Richard** mentioned that the lead Access Ranger for the area is **Phil Waite**, who lives in Contin. Phil is both a runner and a cyclist and uses the tracks and paths across the GDCC area regularly, meaning he knows them well and would be quick to spot and report any problems. Richard was confident that if there were any issues requiring attention, Phil would have already raised them.

**Sadie** remarked that she had not realised how close Phil was based, and welcomed that local coverage.

## Overview in brief given in respect of Garve Hotel.

- GDCC in contact with hotel representatives.
- Tidying the exterior progress made with removing weeds and some rubbish
- Two commercial skips are on site and workers remain on site in caravan
- Power is on; lights visible in various windows.
- Hotel break in Friday night, 15 July. Not on August Police Report
- Email sent to Police Scotland registering dissatisfaction being referred. No update will raise at quarterly Inspector meeting if no update beforehand.

## **Closing Thanks**

With no further questions, Bob thanked Richard for attending. Simon also expressed appreciation for the detailed report. Richard agreed to forward his phone number to GDCC, so members could contact him easily if any issues arise.

# Sadie attended Dingwall Medical Group {DMG} CCs Forum meeting 15th Sept. 2025

- Discussed, vaccines, and although the MSPs have been saying they're coming back into surgery, they've been championing that, they've been telling people to get their vaccines. They're not back in surgery yet, and no date for them to be so either. That's given a knock-on problem where people are still not getting their vaccines, and it's a little bit disingenuous It's generally felt, that the same message is going out by MSPs and MPs, "Go and get your vaccines", but in fact, people have still got the same difficulties. Their appointments are a long way away; they can't easily get there. The doctors are noticing a decline in the uptake of vaccines, and since that message has gone out that they are going to be taken back into practice. People have been tipping up and saying, oh, while I'm here, can you just give me my flu jab or whatever. And they can't do that because they don't have a stock of them in the fridge. So, they're still waiting on that. They still want us to push with, our own MSP on that to find out if that can be moved on a little.
- No Diabetes update, other than the letter that you got via MSP, already shared through when we shared on our website.
- Resilience from the DMG point of view the practice, if there's any power cut for any
  length of time, and they go offline, they've got a process in place to take notes on paper
  because medical records are held on computers now. If there is an electricity outage for
  an elongated period, they actually have another building, for business continuity, where
  they will go in to a different building and be able to connect to their computer systems.
  The also have mobile phone numbers for when their landlines are down during power
  outages and the like, but we did point out, of course, that not everybody's mobile phone
  is working in times of outages.

• Resilience plans within communities were mentioned, idea of having a sub group of the DMG CC Forum to work together so that efforts are not duplicated

#### **DMG**

- Have couple of new admin staff.
- Have had people off on sick leave and also maternity leave.
- Have got a new doctor.
- Are continuing with that outreach program with Traveller Community, which is going really well.
- Have started a new project, for people that have got chronic kidney function -new work group going with one of their doctors and a doctor up at Raigmore and are really pleased with the way that's going.
- Apologised for the fact that they said that they haven't been getting their phones answered very quickly, but that's because they've been down on admin stuff, and they hope that that's going, improve anyway.

**Bob:** Back to the vaccines, I was expecting to be told for my Flu one to, go into Strathpeffer. I got an email and given a date in October to go into Dingwall to the Legion. Date didn't suit and was able to rebook an earlier slot online for Friday. Worth those who are able to trying to book online - although others have not had such luck historically, hence the discussion.

**Caroline:** It's a pity Strathpeffer doesn't have such a group, you know, because most of our residents probably go to the Strathpefer surgery. We used to have a Public Participation Group years ago, but it dropped by the way.

**Sadie:** I've actually spoken with Dawn about it - Dr. Westwood, it was something that she was planning to get off the ground like the DMGCCF, once she got a Practice manager in. Will follow up with Dr. Westwood.

**Caroline:** Dr Westwood retiring had seen an advert.
