Minutes of meeting 9th November 2016. Fortrose Leisure Centre.

- 1. Welcome & Apologies. Special welcome to the newly co-opted members Emma and Vikki.
- 2. Minutes of last meeting: approved. Proposed by IACB Seconded SA
- 3. Matters Arising (if not an agenda item):

Meeting with Ian Moncrieff from Highland Council. Iain Moncrieff met with Iain Brown, Anne Phillips and Cllr Craig Fraser to see traffic & parking concerns situation on Fortrose H. St and to familiarise himself with the area. Cllr Fraser raised issue of pot holes. Mr Moncrieff also went to Rosemarkie (20mph speed limit stressed) and Chanonry Point (where he could see issues with parking.) General discussion followed.

Action point: concern raised re: pedestrians walking from Fairy Glen onto the main road. Will look at signage for next season. VT to follow up with RSPB. /VT

Coastal protection

Informed on 28/10 that Members of Ross & Cromarty Committee (for the Fortrose and Rosemarkie Common Good Fund) approved funding to enable a brief to be prepared to make recommendations on coastal protection at Rosemarkie Caravan Park. (See www.highland.gov.uk for full report.) Wallace Stone to carry out the survey. Request for £11,000 to enable this work to be completed.

Marine House: approval not yet given. Archaeological study needed to ensure nothing disturbed. Project possibly set back a few months. Discussion followed on planning gain issues. FRCC position is that any planning gain from this project should be spent in our community.

8 Licensing: nothing to report.

9 Local Councillors' update: none present at meeting. Nothing to report.

10 Communication: newsletter. 2-week lead time needed to print. Awaiting information for the Community Spotlight page. Hope to circulate before mid-December.

11 Community Issues

Mother and Toddler Group: want to move to Fortrose Town Hall. They have outgrown the Dolphin Room. Town Hall has space but no storage for toys.

Action points: LT to liaise with group Chair Maru Fraser. GP to source a storage shed for toddler group toys. LT/GP

Dog Poo Bags: resident mentioned increase in dog mess after the free bags were cut back by HC. FRCC to trial free bags in various village outlets. Target: the occasional forgetful dog owner. FRCC will also undertake a dog bin audit.

Action points: SA to source eco poo bags. LT to undertake dog bin audit. SA/LT

Fortrose Christmas tree: is there to be a Xmas tree in Fortrose?

Action point: Eilean Dubh to be asked about hosting tree again. /LT

12 Chanonry Point (2017 traffic management)

Meeting on Friday 2nd December 2016 with all stakeholders. SA & AP to attend.

FRCC priority will be for improvements for next year – what can be achieved – as well as looking to the longer term. Discussion followed. Noted that when visiting the site lain Moncrieff referenced a number of simple ideas that will help.

Action point: SA to report back at December meeting. /SA

13 Black Isle Community Councils joint meeting:

Informal discussion on broadband, transport, care home provision and speed.

Broadband: Fergus Weir (Teclan – digital marketing company) presented to the meeting. He has invested heavily in securing 200mb of bandwidth for his business premises in Tore. This can potentially be 'shared' on a commercial basis using wireless line-of-sight technology to other households on the Black Isle. ScotNet would be the ISP for his plan. This is similar to the 'model' Mike Hicks is promoting on this side of the Black Isle. Mr Weir will be hosting a public meeting to explain more fully in early 2017.

Transport: the new representative from Stagecoach – Philip Prestwood was present. All bus contracts are up for renewal in April 2017. He informed the meeting of new bus times. Minor changes to 26 route from Jan 9th 2017. SA raised issue of buses being more 'in sync' with train arrivals to minimise car journeys.

Care Home provision: general discussion. Consensus was that the shortage is a Black Isle problem requiring a Black Isle wide solution and that any new provision should primarily be for Black Isle residents. These points of principle to be agreed at FRCC December 2016 meeting when Tom Heath can attend.

Speed: proposal that the 20 mph proposals for Inverness apply to rural areas.

14 A.O.B

FRCC Associates: request from CC Member that Douglas Stuart become an Associate with specific remit to work with IB on Common Good Fund issues. All agreed.

Action point: SA to canvass views of other co-opted member applicants for a role. IB to confirm with Mr Stuart. IB/SA

Community Planning: idea of an open day surgery suggested for residents to put forward their suggestions/ideas for feasible improvements to the community.

Action Point: VT to bring plans to December meeting. /VT
