2.0 Minutes of last meeting

3.0 Matters Arising

- 3.1 Tulloch's community contributions. SA circulated second draft letter, agreed to send. Action: SA
- 3.2 Letter from Edward Mountain MSP: SA contacted his office twice regarding a meeting with no response. No further action anticipated.
- 3.3 Footpath map boards: In hand, SA exploring option of school project. C/F Action: SA
- 3.4 Crawford Avenue: Main concern is broken fencing. TH to contact HC for removal or replacement. C/F Action: TH
- 3.5 Former Janitor's House (Fortrose Academy grounds): JB said property belongs to Education Department at HC, decision on use will be taken by them but JB understands it's going to remain as a house.
- 3.6 Flagpole in King George V Park: DS to assess condition and contact Ian Goode at High Life Highland. C/F Action: DS
- 3.7 Additional street name requested for consideration "Lackie". CC members agreed to put forward proposal. C/F Action: SA
- 3.8 Avoch Primary School bus services: Multiple issues arising with the buses since the start of this term. LT attended last Avoch Primary School Parent Council meeting who are taking the issue forward. JB recommended further complaints should be directed to Ward Cllrs. JB to clarify who is responsible for children whilst they are on the bus to school. Action: JB

7.0 Planning/Licencing

- 7.1 Care Home (17/02523): Application was passed at the NAPC meeting on October 17th. Whilst unable to vote all three of our ward councillors supported the application. The popularity of the decision locally may be judged by the exceptional response to our Facebook posting announcing the decision.
- 7.2 Correspondence complaining about the closure of an access from Chanonry Crescent to the Fisherman's Salmon Path. The access has been blocked by a fence erected by the landowner who was concerned about abuse of the land, particularly by dog owners. These complaints were referred to Philip Waite (Highland Council Countryside Team Leader) who is now in discussion with the landowner and a resolution satisfactory to all parties seems possible.

8.0 Common Good Fund

- 8.1 Separate closed meeting with HC Common Good representative (hopefully) scheduled for Monday 27th November between 6pm and 8pm (tbc)
- 8.2 Coastal protection: TH to advise Di Agnew of failure of 2016 Scottish Water Gabion Scheme. Action: TH

- 9.1 Discussed changing minimum number for a quorum, currently in constitution 4 is a quorum. C/F to December when full CC in attendance.
- 9.2 BICCs Meeting: Potentially early December meeting with speaking talking about on Community Empowerment. Awaiting date from Di Agnew. Action: SA
- 9.3 Response to FB post for volunteers: Volunteer came forward. Recent school leaver who will be helpful for posters, admin, newsletter assistance. Fortrose volunteer 'ground force' group established (see 10.11) Action: SA

10.0 Community Issues

- 10.1 Fortrose Harbour Bi-Centenary celebrations, AP represented FRCC.
- 10.2 **Rosemarkie Fireworks:** thanks and congratulations from FRCC to Rosemarkie Amenities for a fantastic event.
- 10.3 Academy St Picnic Area: Ward Manager has verbally agreed to fix the fence based upon more competitive quotes. SA has submitted written quotations to Ward Manager, as requested. SA feels the fence needs to be replaced, not repaired. Meeting agreed. Meeting also agreed that this has been going on for too long. Vote was carried to go ahead and get the work done ASAP. If the money cannot be repaid by Common Good funds then CC will absorb the costs. SA to inform Ward Manager of the decision. Action: SA. CC also noted that a resident (who wishes to remain anonymous) has kindly donated new benches for this area. RM agreed to be CC 'lead' for this spot. Action: RM
- 10.4 **Christmas Lights:** David Grigor available Saturday 2nd December to put lights up with RM. SA asked if new lights were to be purchased from the Amenities fund raising. CC not purchasing new lights this year. Feeling that there was now too little time available. RM agreed to liaise with David Grigor. **Action: RM**
- 10.5 **Rosemarkie Christmas Tree:** AP and AM liaising with Rosemarkie volunteers. **Action: Rosemarkie Volunteers**
- 10.6 Fortrose Christmas Tree: IACB to lead as per previous minutes. Stand/base for tree and lights required. Action: IACB

- 10.7 **Christmas Eve Carol Singing in Fortrose Cathedral:** TH has gained permission to use the Cathedral again. **Action: TH**
- 10.8 **Speeding:** Bin stickers, SA to order 'slow down' stickers for when you enter Fortrose from Rosemarkie. AP to order '20's plenty' stickers for Rosemarkie area. AP has signed up for the '20's Plenty' national campaign. C/F as an agenda item for December. **Action: SA/AP**Agreed, on reflection to leave Fortrose smiley face speedometer on Canonbury Terrace near St Andrew's Walk as it's a crossing point for residents.
- 10.9 Grit bins: AM checked all bins 3 weeks ago, HC refilled bins 2 weeks ago. SA chased grit bin to be returned to the bottom of Manse Brae. Bin removed from Station Crescent, AM to query. Action: AM. FRCC to coordinate Winter Resilience Scheme provided by HC. TH to post Facebook message to public informing of grit bin availability. Action: TH.
- 10.10 **Grass cutting:** To be monitored in the spring.
- 10.11 **Fortrose Volunteers:** group is now established. Ward Manager informed. Clearing/tidying up St. Andrew's Walk is the first project. Meetings held with relevant HC personnel ahead of this work happening.
- 10.12 **Community Brown Bin:** Fortrose community brown bin now delivered and sited at Fortrose Academy.
- 10.13 **Next newsletter:** community self-help/community resilience a suggested theme for the next newsletter.
- 10.14 **Fortrose Noticeboard**: replacement too expensive. IACB has organised a repair. **Action: IACB**
- 10.15 **Anti-social behaviour:** SA to create a public information notice for residents in and around the Dean's Road area in light of recent events and subsequent private approaches from concerned residents. **Action:** SA
- 10.16 JB has requested the removal of the bus shelter on Deans Road. JB to chase. Action: JB
- 10.17 **Dog bin map:** See point 4.1.
- 10.18 **Streetlights:** A number out in Rosemarkie, 4 out along Canonbury Terrace. TH emailed HC who are to attend next week.
