Fortrose and Rosemarkie Community Council Meeting Wednesday 9th September 2021 7pm by Zoom MINUTES

1. Welcome and apologies

7-7.30 Engagement with Highland Council

Shane explained the plans for the Temporary Road Traffic Order affecting parking in Rosemarkie. It will be 18months before the order becomes permanent during which time a consultation will take place. The double yellow lines in Rosemarkie High Street are being repainted but we are being given a chance to suggest some changes before this is done. Double yellow lines will go right down the side where the Spar is but on the opposite side a timed parking area for the shop and resident's area could be discussed. It was very important to residents that the businesses had a specified parking area.

TW asked why Fortrose had not had this opportunity before the lines were repainted SM said there would be a chance to discuss before the TRTO became permanent.

Marine Terrace - Access issues for 12-24, fuel deliveries and emergency vehicles. Double Yellow lines will go down opposite the drives to prevent parking this will also create spaces for cars to pass. Double yellow lines will be all along on the residential side of the road. From Mill Road to Hawkhill double yellow lines adjacent to properties, parking bays, permit bays and disabled parking with time limited parking on seaward side. No overnight parking 9pm-8am.all year not seasonal.

One way System - down Mill Road along the front to Hawkhill junction. This will be all year. SM was thanked for attending the meeting and giving Rosemarkie residents a chance to make amendments Residents will be notified and views gathered as widely as possible.

7. Planning

Concerns raised about the height of the new houses at Greenside, 2metres above greenside farmhouse, complaints from several residents. F&RCC have commented through planning portal.

9. Common Good

- 9.1 Coastal Erosion There is funding available through Coastal Communities fund. We would like to put a package together for our area ready for the next funding stream.
- 9.2 Management of our Common Good funds.- Nairn and Dornoch have been in touch again. We will look at the THC quarterly meeting minutes for Common Good

10. Community Issues/ Consultation

10.1 Chanonry Point - The Action group has met again to further discuss improvements. The group is liaising with THC staff and Rangers. A recent venture was to restore the footpath from the car park to the beach to its former wheelchair friendly state, most of the path is complete but a call will go out for volunteers when the project is to be finished. The roundabout will also be tidied.

10.2 Road Safety and traffic management - the issue of 20mph in Rosemarkie has been raised repeatedly for too many years a report will be sent to MSP's. Extending 20mph in Fortrose is also an issue especially Ness road where the care home is.

The poor accessibility for wheelchairs and buggies is another concern we are addressing by compiling a list of areas needing dropped kerbs. JB said that when Ness Road is resurfaced kerbs opposite the Care Home will be dropped.

- 10.3 St Boniface committee only two new volunteers from last recruitment request, relaunch early next year.
- 10.4 IMFLDP-community building- FRO2 JB pointed out that the site marked in the plan for a primary school was not owned by THC.
- 10.5 Fireworks consultation- There are proposals to tighten regulations about selling and specify the dates and times for firework use.
- RAA are unlikely to hold their event this year due to the continuing spread of covid infections.
- 10.6 Great british Beach Clean and other village tidyingevents Rosemarkie Beach Clean will be 18th September
- 9.30 Rosemarkie beach. Fortrose clean yet to be arranged.
- 10.7/Community garden and growing AP to contact RAA about tidying verges etc. in Rosemarkie and volunteers for Fortrose.
- 10.8 Footpath monitoring and maintenance volunteers have been tackling this in both villages and AP has been asked about a machine which could tackle heavy duty jobs with a flail head and can be adapted with a brush for snow. AP will prepare a funding application to Awards for All.

- 10.9 Information sharing among groups in IV10 AP collating information about local groups.
- 10.10 Community Development Trust deferred to the next meeting to give more time for discussion.
