AP wished to point out that request from GHM to meet last year was not ignored .D macLean emailed AP in July asking her to find out views of CC and RAA before plans were public.. She forwarded email to the RAA chair who emailed DM in August suggesting a joint meeting and proposed a forum for groups active in Rosemarkie. DM accepted and RAA chair proposed a meeting in September, CC next meeting was also due in September when plans could be discussed. Neither AP or RAA chair felt they could comment without consultation. DM did not respond

Infact GHM plans were already in public domain and were widely advertised before we could respond.

CC had arranged the public meeting with GHM in order for them to explain their plans for 19 High street. The meeting was prejudged by DM saying in press CC meeting was mischief making and saying objectors were creating a toxic atmosphere. AJ spoke to the journalist who confirmed those words were used by by DM.

CC members were so concerned about the inaccurate statements made that a verbatim account was written from the recording of the meeting and is on our website. GHM statements are on the planning portal. The CC wishes to restate that it supports the museum and AP had previously suggested a meeting to work with GHM in finding a permanent home which did not affect local housing stock.
