2	Minutes of the Last Meeting Proposed Lucy Vaughan, seconded Kerry Ward. Agreed.	
3	Matters Arising None.	
4.4.1	Points from the public/correspondence Road safety: TS reported that a number of residents were concerned about speeding/poor road manners on St Andrews Walk/Harbour Road in Fortrose. There are concerns that it is being used as a 'rat run", that the road is very narrow especially when used by camper vans, and that visibility at the junction is poor. KW noted that signage from the High Street suggested that it was the main route to Chanonry Point. AP said that road works on the High Street may have aggravated the issue. LV noted that the footpath down from the High Street needed improvement. AP said that both the path and the road are at risk due to damage to the seawall. TS to discuss concerns and investigate possible improvement. LV noted that traffic speeds on Feddon Hill were too high and that dangerous overtaking was putting pedestrians, including school children, at risk. 4.3	RAA planning application: It was agreed that FRCC would support Rosemarkie Amenities Assoc in a revised planning application for (existing) storage units near the Beach Cafe.	, ,
4.4	Black Isle Swimming Pool: TS noted the high level of local interest in the decision of the BISP trustees to hand over assets to the Puffin Hydrotherapy Pool in Dingwall. TS had attempted to get in touch with the directors listed on the	

	Companies House register and via other means to clarify the reasons for the decision. AP noted that the most recent board meeting notes from the group indicated that handing over funds to the Puffin Pool was an option but it was not clear if/when a decision had been made. Some donated money had been given back to Avoch Bowling Club. AP said that the objective of the group was to teach children to swim and life-saving techniques and that was not the objective of the Puffin Pool, no matter how laudable. AP felt that money should be ring-fenced for local children's swimming lessons. JP and LV acknowledged the local disquiet and the difficult position the trustees faced. FRCC noted the deep local unhappiness, and is disappointed at the lack of consultation and the absence of a clear public explanation of the reasoning behind the decision. TS to liaise with other Black Isle CCs to seek a response from BISP trustees. TS to speak to Tullochs/Springfield regarding plans for the land that had been earmarked for the pool.	TS
5	Police Report No report received. TS to liaise with MMM to encourage Police Scotland to provide a monthly pan-Black Isle report, which is now more urgent given recent vandalism concerns.	TS/MMM
6	Treasurer's Report BL submitted a full report in absentia. Income this month was from fees for St Boniface Fair stalls. Expenditure included costs of the Senior's lunch, hire of the meeting room for the AGM and minor maintenance costs for Fair stalls, in addition to the monthly mobile phone payment. The balance on 28/6/24 including the deposit account was £6514.90.

No comments Holiday cabin, Pleasant Point, Eathie Road, Rosemarkie: It was noted that this was more holiday letting. FRCC not aware of local objections. RAA revised application: see 4.3 Co-op development: TS confirmed that FRCC had submitted a comment in relation to the application for an extension at the rear of the current store, noting concerns over lorries loading/unloading. Several local residents have lodged objections, based on lorry deliveries and access.	

8	Licensing  No new applications. Further to a query at the AGM, TS had established that short-term holiday lets do fall under the licensing authority however CC's statutory right to discuss and make comments regarding holiday accommodation does not appear to have been tested. TS also noted that THC short-term let application area is non-searchable and not user-friendly. It was agreed that FRCC should watch for future applications for short-term holiday letting.

9.2	Common Good: AP said that the sub-group has drafted a letter regarding concerns over the historic sale of Common Good land, in particular at the campsite in Rosemarkie by the Boat House and at the corner of Castle Street, Fortrose. Investigations by a resident had also uncovered that THC did in fact own the land at the Slog steps in Rosemarkie which due to uncertainties over ownership, the developer at Greenside had not, as agreed, improved. Concern was expressed about routine parking on the Hawkhill Road/Marine Terrace junction by one particular vehicle, pointing in the wrong direction, which led traffic to believe it was still possible to turn left onto the seafront. Regarding a site for an overflow carpark, TS confirmed that Scottish Water would be prepared to sell the land it owned by the Camping and Caravan site. It was agreed that on-going traffic and parking issues should be FRCC's top priority for the next 12 months. TS to meet MMM to discuss how best to make progress.	TS/MMM
