## <u>25/0158</u> Matters Arising from Full Council Meeting 6<sup>th</sup> May 2025

- a) Queens Platinum Jubilee Bench The bench base will be in the coming week. It was **AGRRED** that the bench will be changed from a wooden bench to a composite bench.
- b) History Board The Clerk gave Councillors four layouts to choose from. It was **AGREED** that the boards will look like layout one (appendix one). Furthermore, it was **AGREED** that the topic areas for the boards will be the war memorial, the water tower, the Stanton tunnel, the church and the highway man from Stanton.
- c) Linkup Path between Public footpath14 and the pavement outside 206 Melton Road Cllr Danielson has had correspondence from Nottinghamshire County Council that the petition will be considered at the Nottinghamshire County Council meeting on the 23<sup>rd</sup> September 2025, and an updated will be received after the meeting.
- d) Tree Preservation Orders The Parish Council have now received confirmation that all of the tree preservation orders they requested have now been granted (appendix 2)
- e) Planters at the Village Signs Cllr Healy reported that the planters struggled this year due to not having enough water. It was **AGREED** that the Clerk will contact the company who does the hanging baskets in Keyworth to see if they could come and water the planters. Furthermore, it was also **AGREED** that clerk will try and contact some local companies to see if they can water the planters.
- f) Parish Council Notice Boards The Parish notice boards have now been cleaned; it was **AGREED** that the Clerk will update the backing paper and information in the notice boards.
- g) Telephone Box on Melton Road The Clerk has spoken to Community Heartbeat Trust who have said they will call her back. It was **AGREED** that Cllr Healy and the Clerk will keep chasing the Community Heartbeat Trust.
