After a lengthy delay due to the Covid pandemic, the new village gateway signs have been erected at the three main entry points to the village – both ends of Melton Road and the Stanton Lane/Willowbrook junction (pictured above). The artwork on the signs depicts three key elements of the village – the railway test track, the golf course and the parish church. Bus Service Stopped

The Parish Clerk has been advised that the Nottingham to Melton number 19 bus service run by Centrebus, which serves a number of villages in the area, is stopping on April 10, due to lack of use. In recent years this service has been much reduced, to only five buses running each way Monday to Friday only. The loss of this service will obviously be a blow for those residents who have made use of it, particularly those who have no other means of transport. It also highlights the problems of poor public transport provision in rural areas.

The only remaining bus service in Stanton is now the 853 run by Notts County Council, timetable below:

Stanton – your concerns

Stanton is a lovely village but, as with everywhere, nothing's perfect! As the village is so spread out, there are matters which may be of concern to residents in some areas and not so much in others. From conversations with residents, speeding and littering are often flagged up. The state of the roads is another major gripe and Thurlby Lane in particular has suffered badly due to rerouting of traffic following a closure of the Melton Road. Thurlby Lane also suffers from antisocial behaviour such as flytipping and drug dealing.

Planning matters and the environment are other important issues, especially as a large part of the village falls within the Green Belt. Your Parish Council may not be able to help with all these matters directly but it's important that you let them know what concerns you have so that the appropriate authorities can be notified. So, how can you make your voice heard?

- You are very welcome to attend any meeting of the Parish Council – there is always a public session listed on the agenda. As well as Parish Councillors, meetings are usually attended by both Borough and County Councillors and they are a great source of help and advice.
- The Annual Parish Meeting is an opportunity to discuss issues of interest or ask Parish Councillors about matters such as planning or finance. It's usually chaired by the Chairman of the Parish Council who gives a report of activities over the past year and then opens up the meeting for questions and discussions.

Water Tower





New residents to the village might not be aware that there used to be a water tower on the land adjacent to the entrance to the business park on Browns Lane. This was demolished in 1984 when it was superseded by a pumping station which took over the job of supplying water to high lying villages. These photos of the demolition were kindly provided by Richard Butler and taken by his father, the late Roy Butler, a Stanton resident of long standing.

NOTIFICATION OF CASUAL VACANCIES

NOTICE is hereby given in accordance with the Local Government Act, 1972 Section 87 (2) that a vacancy exists for two Parish Councillors in the parish of STANTON ON THE WOLDS.

If within 14 days (excluding Saturdays, Sundays or Bank Holiday breaks) of the date of this notice, TEN electors for the electoral area giving notice in writing of a request for an election to fill the vacancies to the "proper officer" of the Borough Council ("proper officer" in this case is the Returning Officer), an election shall be held within sixty days beginning with the day on which public notice of the vacancies was given.

If no such notice is given, the Returning Officer will notify the parish council who may then fill the vacancies by co-option.
