- 68/24 Somerset Councillors Report: (i) Winter Maintenance SP shared the salt bins and bags map for the parish. CO asked whether the PC could replace some of the bags with bins along the Simonsbath/Kinsford/S Molton road. Clerk will email all Cllrs with prices so that a decision can be taken to the Highways Warden's meeting on 5th September. FS will attend this meeting as AC will be away (ii) Landslip above the sawmill this is checked weekly but there is no timetable for repair. Kier, the new highways contractor, is taking some time to settle in. Cllrs pointed out that the barriers erected to protect the site cause the road to narrow at a dangerous point; pedestrians & horse riders take their life in their hands as they are passing it is a safety issue. Clerk to contact Structures team again (iii) The ENPA Forum held earlier in the month discussed carbon offset schemes where parcels of farmland are being purchased by large national and international companies to plant trees. Many parishes are concerned that Exmoor will move from a farmed landscape to forest, thereby removing communities (iv) Buses with the change in government it is unclear what the policy will be on buses.
