**Freedom of Information (Scotland) Act 2002
Request for Information**

Thank you for your request for information which we received on 19 April 2016. Your request has been dealt with in accordance with the Freedom of Information (Scotland) Act 2002.

Please find listed below your requests for information and our responses:

1) *Who owns the Title deeds to the Stonehouse Lifestyles building.*

The site and buildings are owned by South Lanarkshire Council (SLC).

2) *Is there an agreement between South Lanarkshire Council and SLLC on the management and running of the lifestyles or similar halls within South Lanarkshire? If yes can a copy be provided?*

There is at present no lease for this particular site. However, I have enclosed a copy of the standard lease that is used (Appendix 1). This has the site specific information blanked out (hence the missing pages) and the personal data of the signatories redacted.

3) *Have SLLC interviewed and engaged bar management and staff to run licensed bars within Stonehouse and other Lifestyles within South Lanarkshire.*
