Freedom of Information (Scotland) Act 2002 (FOISA) Request for Information

I refer to your information request dated 4 August 2023 requesting the following information.

- a) What date did Canderavon close?
- b) Who currently owns the building which was Canderavon Nursing home.
- c) Has any feasibility studies or discussion papers been produced that assess any future plans of this building. If so can the Community Council have copies of these.
- d) Have any building surveys (internal and external) been carried out on this building and when were they carried out. If so can electronic copies be provided.
- e) In addition Stonehouse Community Council wish to register an interest in this building.

Holding the Information

The Council has searched its records and has located all of the information that you have requested.

Response to Request(s)

The Council can give you all of the information that it has in relation to your request. This information is as follows:-

- a) Canderavon closed on 14 March 2023.
- b) South Lanarkshire Council owns Canderavon Nursery Home.
- c) No feasibility studies or discussion papers have been produced that assess any future plans for this building.
- d) The last Building Condition Survey that was carried out was in July 2018 and I have attached this to this letter. I have also attached photographs taken during the survey.
- e) I note your request to have your interest registered for this building and will pass on your contact details to our Community Asset Transfer Officer.

Request for review
