Minutes

 - c. To discuss the Millennium information board issues. Cllr Kennedy-Hill had a look at the board, and there was an old layer of microlon. This was removed and all looks good underneath. P Sharman to replace the microlon and re-site the board as directed.

6. Reports received from County and District Councillors.

County Councillor Stone, spoke about the Devolution and the Local Government reorganisation:

- Devolution: No County Council elections this year. There will be one Mayor covering Suffolk and Norfolk.
- The Local Government Re-organisation will consist of the unitary authorities under the mayor. These are being now discussed. 1) one unitary authority for Norfolk, or 2) two unitary authorities an option 3) two unitary authorities and Norwich City.

- a. 2023/2210 Planning Appeal | Land West Of Greenacres Rectory Road Aldeby Norfolk Proposal: Proposed erection of up to two dwellings (with all matters reserved except for access). Look at what we objected too and use the same reasons to reiterate our objections.

This has been approved. With no conditions on 3rd March 2025. APC were not able to post a comment. Action CC Stone to confirm what discharge of conditions mean. *County Councillor Stone has since reported that "discharging conditions could mean they are no longer relevant and therefore no longer needed. So since Hall Road no longer has the volume of vehicles it no longer needs to be narrower for example."*
