Highlands Astronomical Society — Code of Conduct

The Highlands Astronomical Society (HAS) is committed to creating a welcoming, inclusive, safe, and enjoyable environment for everyone. This Code of Conduct applies to all members, guests, and volunteers participating in our events, meetings, and observing sessions.

All members have a responsibility to act in accordance with the <u>Charities and Trustee</u> Investment (Scotland) Act 2005

1. Respect and Inclusivity

- - Treat everyone with respect, kindness, and courtesy, regardless of age, gender identity, race, ethnicity, disability, sexual orientation, religion, or experience in astronomy.
- - Foster an environment where everyone feels valued, heard, and included.
- Discrimination, harassment, or bullying of any kind will not be tolerated.

2. Enjoyment and Engagement

- HAS exists to promote the enjoyment of astronomy be welcoming, encouraging, and supportive of others' interests and curiosity.
- Help create an atmosphere where newcomers feel comfortable and returning members continue to enjoy participating.
- Respect that people engage in different ways whether through hands-on observing, talks, helping out, or simply learning quietly.

3. Observing Site Etiquette

- Preserve night vision: use red lights when observing and avoid bright screens or white lights.
- Park respectfully. When arriving/leaving sites, keep vehicle headlights to a minimum.
- Respect others' equipment: never touch another person's telescope or gear without permission.
- Be mindful of noise and behaviour to avoid disrupting others' observations.
- Follow any guidance from observing session coordinators regarding setup, safety, and packdown.
- Take your litter and belongings with you leave sites as we found them or better.

4. Safety and Responsibility

- Prioritise the safety of yourself and others. Report any concerns to a Committee member promptly.
- Take care of HAS equipment, resources, and venues whether at the Observatory or other locations.
- Ensure children and vulnerable adults are supervised by a responsible adult unless prior arrangements have been made with the Committee.

5. Communication and Privacy

- Communicate respectfully in all society settings, including meetings, emails, social media, and online forums.
- Avoid offensive or inappropriate language. Assume good intentions but address concerns with sensitivity.
- Personal information shared within the Society must be kept confidential, in line with UK GDPR and our safeguarding commitments.

6. Security and Supervision

- All attendees should sign in and out at meetings and events when required.
- Help newcomers feel welcome. Politely challenge unknown individuals if appropriate or alert a Committee member.
- Keep personal belongings secure and report suspicious activity or hazards to the Committee.

Breaches of Conduct

- Any concerns or breaches of this Code should be reported to a Committee member or the Chair.
- Issues will be handled fairly and confidentially in accordance with our disciplinary and safeguarding procedures.
