#### The JSL Observatory.

The JSL Observatory houses a fully computerised **Meade 14" catadioptric telescope** within a Pulsar 9 foot dome. The main telescope supports an **80mm refracting telescope**. The adjacent observing station has disabled facilities including a lavatory and a laptop with a large wall mounted screen which is used to view telescope images remotely. It also houses the Society's library, and has room to allow us to hold small groups. We have a computerised EQ3 mount for use with our smaller telescopes, a **Skywatcher MAK90**, a **60mm refractor** and a **4" Vixen refractor telescope**. These offer alternate views from smaller telescopes. We also have an **8 inch Vixen Schmidt** — **Cassegrain**. We were kindly donated a radio telescope for use on cloudy nights. We can also offer 4 pairs of 10 x 50 binoculars which are available for loan to society members and visitors.

We normally meet once a month in the Smithton-Culloden Free Church with Youngstars sessions led by Pauline Macrae and Trina Shaddick. Guests are welcome at our meetings. However we only had one indoor meeting this year due to Covid restrictions preventing social gatherings, the meetings in April and May being cancelled. Our AGM was undertaken via the internet, the members being sent the normal AGM papers via the email. The required quorum numbers were reached and the report was passed without alterations. From June our monthly talks were given on Zoom (including a December Quiz —which was organised by SIGMA with members of other Northern astronomy Societies). The Zoom talks are later edited and uploaded to YouTube by Eric Walker.

Due to the Covid situation all visits to the Observatory were stopped as were the planned Science Festival in May, Belladrum in August and the Highland Council 'Open Doors' event in September. In October, the Observatory was visited by a children's author, Corrina Campbell, and her publisher to launch her new children's book called "The Girl Who Stole the Stars" via Facebook. No visitors were allowed and there was just one member of HAS there.

Eric Walker was asked to become a member of the Orkney International Science Festival's 2020 Online Technical Team & Presentation Team. This proved very beneficial to the individual and to our Club as the training and experience of OISF2020 helped us design and construct live observing webcasts at 1080p with interactive co-host & audience participation — these are very popular & successfull. YouTube recordings of these webcasts have enabled us to appeal to another cohort and grow our membership. These skills were also used when Eric Walker became involved in National Astronomy Week in November when he broadcasted twice during that event.

We continue to campaign for dark skies, are a 'community consultant' to Highland Council.
