	Sewage capacity is a wider issue locally. However, SWW has a statutory obligation to create capacity.

(ii) the water main just over the bridge in Fiddlers Green has burst and needs repairing. (iii) Gregory Lorries are still driving through Mitchell Village and not carrying on down the A30 to Carland Cross (iv) There is a large pothole just off the B3288 at Boxheater. RESOLVED: Clerk to report all issues.</li> <li>(b) Mitchell Village Hall: The Clerk advised that the Planning Officer is satisfied with the revised proposal for pedestrian access to the site and that a decision is imminent. NOTED.</li> <li>(c) Transfer of the Land on the Tremellyn Estate: The Clerk had received the plan for execution and that the transfer will be completed as soon as the solicitor receives a signed copy of this document. RESOLVED: The Chair and Cllr. Rowse signed the plan for the Clerk to return to the Solicitor.</li> <li>(d) Works to the Play Areas in Mitchell: The Clerk gave an update on the new equipment which includes a springer &amp; 2 play panels for St. Francis Meadow and a trail for the main play area. The S106 money has been received and the equipment ordered. The Clerk has also received a quote for the maintenance work at St. Newlyn East Play Area arising from the risk assessment, which she would like approved.
