9. Consultation on Chilton Road & A417 London Road (Upton) Proposed Traffic Management & Toucan Crossing. Proposed cycleway.

Comments

Chilton Parish Council has the following comments on the Chilton Road and A417 London Road (Upton) proposed cycleway.

The top of Hagbourne Hill is a serious problem area, the interchange at the top has not been adequately considered. Hagbourne Hill is a fast road and with the closure of the Chilton Road there will be an increase in traffic, which will make it more difficult to cross easily. There is a lack of a safe crossing for cyclists and pedestrians and the traffic calming chicane at the junction will not provide this.

None of the 3 proposals in the report adequately addresses this issue, also the report does not consider the use of the Lynch Way as an option and it should have been.
