## Traffic enforcement measures on George Street, Corby

The grace period for traffic enforcement measures on George Street came to an end on Tuesday 15 October.

Anyone not permitted to drive through the section will now receive a Penalty Charge Notice (PCN).

Anyone found to be breaching the order faces a PCN of £70 (reduced to £35 if paid within 21 days).

Only taxis, buses and cyclists are permitted to enter the main crossing section between 8am and 6pm from Monday to Saturday.

The measures were first introduced in April this year to improve safety for pedestrians crossing the road. The previous traffic regulation order (TRO) was replaced with one that enables North Northamptonshire Council to enforce vehicle access restrictions, using automatic number plate recognition (ANPR).

## NNClimate24 - How will North Northamptonshire face up to a changing climate?

Our annual climate conference, [NNClimate24](#), will take place on Thursday 21 November. It will be virtual to reduce the carbon footprint of the event.

The main themes will be:

- How will the people of North Northamptonshire prepare for the effects of climate change?
- What can be done to reduce our carbon emissions?

We have some really engaging sessions lined up:

- **Session 1: Health effects of climate change (9:50am to 10:50am)** - Adopting a public health approach to tackling climate change. Keynote speaker: Dr Ebenezer Laryea, Associate Professor of Sustainable Development Law, University of Northampton.
- **Session 2: Sustainable living (11:30am to 12:10pm)** - The power of the circular economy and sustainable waste management. Keynote speaker: Dr Margaret Bates, Head of UK EPR Scheme Administrator, Resources and Waste, Department for Environment, Food and Rural Affairs (Defra).
- **Session 3: Engaging communities for climate action (12:30pm to 1:50pm)** - From grassroots to local impact. Keynote speaker: Mark Thomas, Headteacher and Designated Safeguarding Lead, St Peter's School, Kettering. Matilda Crane, Regional Hub Manager (East Midlands) for the Climate Ambassadors Scheme, University of Nottingham, will also present.

Each session will be followed by a panel discussion. This is the fourth such forum that we have convened, building on the success of the past three years.

We're already making terrific progress in working towards our ambitious carbon reduction targets and I look forward to this good work continuing.

## **Council teams win award for Health, Safety and Wellbeing project**

Congratulations to teams from across the council (Environmental Health, Communities and Public Health) for winning the Health, Safety and Wellbeing category at the Northamptonshire Logistics Awards last week.

The aim of the project was to get health and safety messages out to otherwise unreachable drivers at the Welcome Break Rothwell Truck Stop on the A14.

North Northamptonshire Council has been working with Welcome Break for two years, focusing on the health and wellbeing of HGV drivers travelling through the area and hosting wellbeing events at the truck stop.

Previous events have seen attendees having blood pressure, cholesterol and weight checks, and partners have been on hand to provide information and advice on diabetes prevention, health and wellbeing and mental health.

This achieved national recognition and was Highly Commended at the MJ Awards in 2023. The team has built on this success by hosting an [online HGV drivers health and wellbeing conference](#) in April this year.

The truck stop project has been well received, and the team continues to spread awareness of the initiative across the UK by talking to the Department for Transport Working Group and Transport Focus.

The Welcome Break Rothwell Truck Stop has also implemented several new initiatives including suicide awareness training for staff, a room on-site to promote the health and wellbeing of HGV drivers, and cycle and walking routes from the site.

As part of the project, council officers wrote a [guest blog for PTSD UK](#) on tackling post-traumatic stress disorder amongst HGV drivers.

## Two child safeguarding reviews published this week

This week, Northamptonshire Safeguarding Children Partnership (NSCP) published Child Safeguarding Practice Reviews into two cases of child sexual abuse in the county.

The purpose of these reviews was to identify improvements to be made to safeguard and promote the welfare of children.

Much of the detail in each report was anonymised to protect the identities of the children involved. To this end, one report was provided as an executive summary, to avoid jigsaw identification of the victim.

In both cases, there were a number of common themes which have been fed back to all relevant organisations, along with a series of recommendations.

## Bluetongue restriction zone extended into North Northamptonshire

On Friday 4 October, the bluetongue restriction zone was widened to incorporate North Northamptonshire. This means that farmers in the area must now follow restrictions on moving their animals.

Farmers can check whether they are in the restricted zone on the [APHA Bluetongue Interactive Disease Map](#) on the Department for Environment Food and Rural Affairs (Defra) website.

Bluetongue is a notifiable animal disease spread by midges which affects ruminants (animals including sheep, cattle, goats and deer), as well as camelids (llamas and alpacas). Cases of the viral disease (BTV3) have been confirmed across the East of England. It does not affect humans, horses or pigs.

If farmers suspect a case, they must report it to the Animal and Plant Health Agency (APHA) immediately by calling 03000 200 301. Symptoms vary across susceptible species but include fever, lesions, redness of the mouth, eyes, nose, reddening of the skin above the hoof, excessive salivation and nasal discharge. Some animals may show few or no clinical signs.

This is worrying time for farmers across the country and I would urge anyone who might be impacted to take a look at the guidance on the [GOV.UK](#) website, check if you are in a restricted area and keep an eye out for updates.

## **SEND student's passion for cooking lands him internship at Chester House Estate**

A student from a SEND college has secured a supported internship within the Chester House Estate's catering team.

After his two years at the [Creating Tomorrow College](#), student Zec Taylor has progressed into his supported internship in [The Farmhouse](#) kitchen, working alongside professional chefs to make, present and serve food and drinks to customers.

Currently, Zec supports day-to-day tasks including making barista-style coffee, preparing and cooking items on The Farmhouse popular menu and perfecting presentation skills on dishes.

The estate provides work experience for students at the Creating Tomorrow College on their Pathway to Employment study programme within its marketing, events, facilities and administration departments. The aim is to help equip them with employability skills to progress into jobs after their studies.

## **New Civic Protocol for Northamptonshire**

A new [Civic Protocol for Northamptonshire](#) has been published under the auspices of HM Lord-Lieutenant of Northamptonshire.

The aim of the protocol is to establish a countywide approach to the civic function and how it is delivered across Northamptonshire.

The protocol seeks to celebrate and preserve Northamptonshire's rich history and civic tradition.

It outlines the roles and responsibilities of various civic figures, such as the Lord-Lieutenant, the High Sheriff of Northamptonshire, the Chairs of West and North Northamptonshire Councils and all the Mayors and Chairs of town and parish councils across the county.

It provides for a consistent approach to civic matters, such as the order of precedence at civic engagements and events.

Additionally, it aims to support local businesses and charities, to promote the visitor economy, and to recognise deserving individuals and organisations within the county.

The Civic Protocol has been developed by the Northamptonshire County Civic Working Group; a group originally established by the Lord-Lieutenant in 2021 as the Platinum Jubilee Committee. Chaired by the Lord-Lieutenant, James Saunders Watson, it includes Father Oliver Coss, Rector of Northampton and representatives from Northants CALC, North Northamptonshire Council, West Northamptonshire Council, and Northampton Town Council.

## Consultation launched on Corby Rail Station parking costs

A consultation has been launched on proposed changes to car parking costs at Corby Rail Station to bring them into line with other stations in the local area.

A pre-consultation held this Summer received 90 responses. The revised proposals include an off-peak rate, extra parking spaces and to make a section of the entrance/exit one way.

It is important that people have their say on issues that impact them. We know that a lot of people use Corby Rail Station every day and often travel in by car.

We want to hear from residents, businesses and visitors about the proposed changes.
