LICENSING

Notice of application for the grant of a Premises Licence under Section 17 of the Licensing Act 2003 Proposal: Mr Stoff has applied to Scarborough Borough Council for the granting of a Premises Licence in respect of premises to be known as East Ayton Lodge Hotel, Moor Lane, East Ayton, Scarborough, YO13 9EW. The proposed licensable activities are:

- Supply of Alcohol on and off the Premises and the Hours of opening 24/7 for residents only, non residents Sunday to Monday 11:00 - 00:30, Friday and Saturday 11:00 - 02:00 -
- Late Night Refreshments for non-residents Sunday to Monday 23:00 00:00, Friday and Saturday 23:00 01:30, residents Mon to Sun 23:00-05:00
- Live and Recorded Music Sunday to Monday 11:00 00:00, Friday and Saturday 11:00 01:30

Residents voiced their concerns over the above licensing application to members of the parish council and to the owners of East Ayton Lodge Hotel.

Members of the parish council listened to the residents' issues and the answers from the owners of the premises and it was then

RESOLVED: That the observations below will be sent to Scarborough Borough Council's Licensing Department. 67/22

After a long discussion, it was agreed that although the parish council do not object to the change of hours for the <u>supply of alcohol</u>, we <u>do object strongly</u> to the granting of a licence for <u>live and recorded music</u> to be allowed to finish at 1.30am.

After speaking with the owners of East Ayton Lodge, Mr & Mrs Stoff, at our parish council meeting on 26 April, they acknowledged the issues parishioners had regarding noise carrying on so late and agreed that they would ensure that music is <u>not</u> played after 12am and would change their licencing application to state that live and recorded music will finish at 12am.

Therefore, East Ayton Parish Council ask that the licence is altered to state that live and recorded music for Friday and Saturday finishes at 12am in line with the other days of the week and that music should not be played outside.
