BUS SERVICE:

To receive an update regarding recent and proposed timetable changes to services 3, X3, 128 and X28. Cllr Peacock has been in contact with East Yorkshire Buses (EYMS) and North Yorkshire Council regarding timetable changes. From

mid-September, services 3 and X3 are being adjusted, with X3 journeys running from Scarborough through to Pickering between 09:00 and 14:00. Service 128 will also see changes, and Viscount Travel have introduced the X28 service between Malton – Pickering – Scarborough. The X28 does not serve Racecourse Road towards Scarborough on most journeys, although it does return that way. NYC have confirmed the X28 is not considered a full replacement for the X3, and funding for the X3 start-up service is not being reduced).
