VIOLENCE AGAINST WOMEN

Powys County Council makes commitment to ending men's violence against women. Delivering a plan to change the cultures that lead to abuse and violence, is among the actions that Powys County Council has committed to by becoming White Ribbon Accredited. It has also agreed to promote gender equality. The council is linking up with White Ribbon UK, which is part of the global White Ribbon movement seeking to end men's violence against women, by making these pledges. Its plan for gaining accreditation includes a new Violence Against Women, Domestic Abuse and Sexual Violence Policy/Sexual Harassment Policy for employees, while ambassadors have been identified, from among its staff, to carry the message out to more men, to develop white ribbon youth advocacy groups within the county's high schools and to raise awareness within Powys communities through online media and campaigns.
