1. **Welcome** - Chair welcomed everyone to the meeting. Everyone was reminded to stay on mute unless they were speaking.
2. **Apologies:** Cllr Pryce, C Cllr Hulme sent prior notice of late arrival.
3. **Declaration of interest** - None
4. **The minutes of the previous meeting** had been sent to all councillors, these were accepted, minutes to be adopted.
5. **Matters arising** - Bank Farm - Pending Consideration. Crematorium Aberhafesp - Pending Consideration. Hazel Grove - Pending consideration. Pot holes - Point Pitch, Tyn y Pales. Blocked drain next to Aberhafesp church, blocked gutters from bottom of Garregllwyd to Aberhafesp junction. Still outstanding  
30mph repeater signs Bwlch y Ffridd - Erected - RESOLVED  
Aberhafesp/b signs waiting for formal portfolio holder decision paper.
6. **Financial Update** - Bank £2977.82 plus £30,000. Invoice for election not received. 1<sup>st</sup> precept payment due on Friday 30<sup>th</sup> April 2021.
7. **Planning 21/0605/LBC** also added at Chairs discretion **21/0706/LBC Flat 2 Aberhafesp Hall**. As these were grade 2 listed buildings it was decided to send no comments, as would be reviewed by Listed Building officer and CADW.
8. **Aberhafesp Speed Review** - To update Cllrs. on current situation. Report from Cllr Amy was sent to all Councillors prior to meeting for any questions/comments. Report had also been sent to Chris Lloyd - Highways before his review of Aberhafesp. Council would wait for report from Chris Lloyd. More Police presence in village was suggested. 7.45pm C Cllr Hulme joined the meeting. The Go Safe van could be asked to visit frequently and speed counters, to assess volume of traffic.
9. **Correspondence** - None
10. **County Councillor Update** - Full council meeting tomorrow, report would be sent out after that. C Cllr Hulme noted that a new planning officer had now taken over the Bank Farm Pig farm planning application, and so would not be in May planning meeting.

11. **Other Issues** - The road through Bwlch y Ffridd to junction at Aberhafesp had been resurfaced and chipped, before any road maintenance. The sides of the road were not solid and potholes had caught a few people out. C Cllr Hulme was waiting for an answer back. Cllr Amy explained the criticism from the last meeting. It was pointed out that the matter should have been brought to a Community Council meeting, apart from C Cllr. Hulme, Chair and clerk none of the other Cllrs knew any of the details if they were approached by a resident. All issues need to be brought to a meeting whether positive or negative, so all councillors are aware, past history and current situation can be checked. Legislation could have changed since the last time, 3 years ago.

With no other issues chair closed the meeting at 8.05pm.
