1. Chair welcomed everyone to the meeting.
2. Apologies – Cllr S Pryce, C Cllr J Yeomans
3. Declaration of Interest – None
4. Members of the public speaking session – Mr Beck asked for our continued support with regards to planning application 25/1690/FUL Land South of Bwlch y Ffridd, and explained what the issues were. It was agreed to support. Clerk to send an email to PCC Highways and planning. Mr Beck to send details of the issues to clerk to enable email to be sent.
5. Minutes of the meeting were accepted as a true record and signed by the chair.
6. Matters arising – Barns at Gethin Waen – Pending Consideration, Rhoslan – Approved, Land South of Bwlch y Ffridd – Pending Consideration – C Clr Yeomans has asked for the planning application to be called in.
Salt bin locations have been sent in, SID Bwlch y Ffridd – Date to be arranged for a site visit.
7. Financial Update
 - 1) Bank Reconciliation – Bank £10,100.25 (£7274.00 earmarked) Dividend account £3983.94
 - 2) One Voice Wales membership £95 Annual membership – Agreed
 - 3) Spanglefish – website hosting £78 due end of March – Clerk has paid.
