- 0721.01 APOLOGIES FOR ABSENCE. M Petrie
- 0721.02 TO RECEIVE DECLARATION OF INTERESTS. Nothing to declare.
- 0721.03 **MINUTES** of the meeting held on **18 May 2021** having been circulated were taken as read and confirmed as a true record.
- 0721.04 ITEMS ARISING FROM THE MINUTES Nothing to report.
- 0721.05 **COUNTY COUNCILLOR'S REPORT.** Cllr Mrs V Jones gave her verbal report on items relating to Northumberland County Council and local issues relating to Whittington Parish.
 - a) **Speed survey.** The results of the speed survey had been received which showed average speeds of 21 mph with the 85th percentile speeds of 27mph and 28mph. It was agreed that the speed survey had been carried out in the wrong area and Cllr Mrs Jones would request that this was carried out again in a different location. An application for 20mph had been lodged and would be funded by Cllr Mrs Jones's members funding. The scheme will be assessed by Highways Department to see if it meets the criteria.
 - b) **Local Transport Plan 2022-2023.** Parish Councils will have the opportunity to submit priorities to the LTP and it is suggested that a 20mph is submitted as one of the priorities.
 - c) A68 accidents. There have been a number of accidents on the A68 due to aqua planning. Northumberland County Council is currently putting a business case together and will deliver the scheme September/October if funding is received. Work will be carried out on the culvert and outfall with a secondary inlet into the culvert and work on the road surface.

- 0721.08 GREAT WHITTINGTON VILLAGE HALL AND THE VILLAGE ENVIRONMENT. The current committee has, as well as organising a number of village events, also applied for two grants. One to the National Lottery for money to overhaul the heating system involving installing an air source heat pump powered by solar panels. The other to the county council's community chest fund for money to install an AV system including a big screen and projector. Applications to both sources were encouraged by Louise Currie. Louise Currie, CAN advised that all members of the Village Hall committee must be a Trustee. Cllr A Williamson is currently a Trustee however a replacement will need to be found in the next few months. Cllr A Williamson will stay on the committee until the AGM in September when he will resign. Cllr J Sadler brought up the subject of Great Whittington having some children's play equipment, possibly in the Village Hall Garden. There is currently funding via the Community Foundation's Windfarm Community Grants. Concerns were expressed over supervision, maintenance and insurance. Cllr J Sadler is to speak to one or two parents for their views and discuss with the Village Hall committee.
- 0721.09 TO RECEIVE COUNCILLORS' REPORTS AND HIGHWAY MATTERS. Several issues reported to Northumberland County Council Highways are still outstanding. It was noted that the flooding issue at Hallington has not been resolved. Cllr S Lawson had sent photographs to Highways Dept. Cllr Mrs V Jones advised that Northumberland County Council had confirmed it was on their list to do.
