## MINUTES OF THE MEETING OF WHITTINGTON PARISH COUNCIL HELD ON 11<sup>th</sup> MARCH 2025 AT 7.30PM IN GREAT WHITTINGTON VILLAGE HALL

0325.01 **Apologies for absence** received from Cllrs M Petrie and S Lawson

0325.02 **Declarations of Interests**. None

0325.03 **Minutes** of the meeting held on **14<sup>th</sup> JANUARY 2025** having been circulated were taken as read and signed as a true record.

#### 0325.04 Matters arising from the Minutes of the meeting held on 14<sup>th</sup> JANUARY 2025.

- a) Hallington Mill. Minute ref 0125.04b refers. No action has been taken.
- b) Grass cutting. Minute ref 0125.06c refers. Cllr S Gregory had spoken to the contactor who will keep the cost for 2025 at the same level as 2024 as long as we allow him the flexibility of the extra cut. This was agreed. Cllr S Gregory will continue to cut the grass at the war memorial in Hallington.
- c) Trees. Minute ref 012508d refers. The dead trees had been removed and smaller trees will be planted.

0325.05 **County Councillor's Report.** Cllr Mrs V Jones gave her verbal report on matters relating to Whittington Parish.

- a) Hallington Mill. Unfortunately, the landowner is not responding to Northumberland County Council, and they have asked for assistance from Natural England. NCC are willing to carry out the improvement work to the field drains however they need the landowner's permission. Cllr S Gregory will try and speak to the landowner to progress the issue. The work on the road markings is imminent.
- b) Halton Shield. The road safety work which was to be carried out imminently has been withdrawn as there is another larger piece of work that needs to be carried out and this will be done at the same time. This will include signage and resurfacing work and will be carried out in May/June when the daylight working hours are longer.
- c) Gulley cleaning. It was noted that the gulleys had been cleared in Great Whittington and Matfen.
- d) A68 safety measures. Northumberland County Council is still waiting for the Police's report with recommendations.
- e) Local Transport Plan. The road from Matfen to the Military Road is included in next year's LTP for resurfacing.
