

Portbury Parish Council: STATEMENT OF COMMUNITY ENGAGEMENT

Background

Community engagement works best where it is an ongoing cumulative process enabling relationships and trust to build and strengthen over time. At the time of writing this statement there is a pressing need to engage with our Community as the Strategic Plan for our District becomes adopted and with it the Neighbourhood Plan for Portbury develops. Portbury Parish Council aims to achieve a high standard of engagement with all our stakeholders. Whilst using primarily electronic means of communication, e-mail, we will also endeavour to stay in touch with harder to reach groups who may not have access to or be familiar with such technology.

PURPOSE AND SCOPE

Portbury Parish Council is the first tier of local government within our community. It is vital therefore that the Council engages closely with the community it serves. The Council and Councillors play a vital role as they make decisions which affect the area in which we live and work. We aim to make a positive quantifiable difference to the quality of life in our community. This statement outlines how we ensure the community is kept informed and enables the community itself to contribute to activities and decision making of this Council for the benefit of the community.

DEFINING THE COMMUNITY The Council considers the community of Portbury to consist of: All residents in the community All those who work in the community All those who own/run businesses in the community All young people who live and/or go to school within the community All local voluntary organisations, clubs and societies Any group or organisation that represents some or any of the members of the above sections of the community
The Council also understands that there are other bodies that are vital to the quality of life in our community and we aim to maintain a good working relationship with them, including the Police, other tiers of local government and neighbouring town and parish councils.
PROVISION OF INFORMATION TO THE COMMUNITY AND OPPORTUNITIES FOR COMMUNITY INVOLVEMENT
 Information is provided to the Community from the Parish Council in a variety of ways including: The Parish Administrator is available to be contacted during day hours to provide a wide range of information on Portbury's activities and issues The Council's website provides information which includes agenda's and minutes, contact details for all Councillors, links to a number of groups and organisations in the community Members of the public can also make direct contact with the Council through this website The Parish Council provides 2 notice boards within the community one in the main Village and one in Sheepway. These are used to display council meetings and all other statutory notices. Sections of these notice boards are also designated for community use for local groups to advertise their up and coming events The Parish Council publishes a quarterly Newsletter which is mailed to its database of registered readers. An annual report is published every year and is reported at the Annual Residents' meeting, usually held in May. This report is also posted on the Parish Council website or
can be collected from the Administrator to the Council.

□ All meetings of the Council and committees are open to the public and a period is set aside for public questions relating to items on the agenda if residents wish to make a representation
□ Public meetings can be held from time to time to gauge public opinion about important issues affecting the community.
☐ Questionnaires are used sometimes to ask local residents about specific matters, these are distributed by both e-mail and at the monthly Community Cafe at the Village Hall.
☐ The Council endeavours to ensure that its e-mail database is up to date and encourages all residents to register their address for receipt of Council Communications.
If necessary, for issues of the greatest importance, the Council will distribute hard copies of documents by hand to all residences in the Parish. This is usually done by the Councillors delivering door to door

COUNCIL MEMBERS AND THE PARISH CLERK

Council members (Councillors) are elected decision makers of the Parish Council. They represent the community and bring issues to the Council meetings for corporate decisions to be made. Their contact details are available from the Parish Website, the Parish Council website and also on the notice boards within the parish. Members of the public are welcomed to contact Councillors to raise any issues. The Parish Administrator is employed by the Parish Council to carry out day to day functions of the Council and has overall responsibility for the management of services provided by the Parish Council. The Administrator, in conjunction with the named Parish Clerk, also advises the Council on the powers available for it to carry out its functions. The Administrator will also advise on current legislation and changes to legislation which are necessary for the Council to carry out its duties.
