1. WELCOME AND APOLOGIES

Robert welcomed Community Councillors to the meeting.

PREVIOUS MINUTES (December 2021) APPROVAL & MATTERS ARISING

2. INPUT FROM MICHELLE STRONG - EDUCATION CHIEF OPERATING OFFICER Ms Strong informed those present that:

- i The Education Chief Operating Officer role covers all aspects of Education (7 Secondary Schools, 32 Primary Schools, and 2 Nursery schools) and the work of Communities, Lifelong Learning, and Employability (CLLE).
- ii The work of the department is informed by the Single Midlothian Plan
- iii The department has made a range of new appointments including a Data Officer whose role is to gather data to support improvement and develop training, a Learning Estate Estates Officer to manage new projects, a Parent and Learning Liaison Officer who helps to shape service delivery.
- iv Have £10.5m to purchase equipment for learning including the supply and provision of 14,000 digital devices that support:
 - Improving the learning experience
 - Engagement with learning
 - Improving attainment
- Rapid growth and development have meant that the Council has to meet the demands of a growing population. This has led to a greater demand on available budgets and resources.
- vi The impact of the recent Covid-19 pandemic has seen an increase in the numbers of young people requiring support who need the right support at the right time.
- vii The findings of the National Education Review require to be taken into account.
- viii The department has received additional funding: Pupil Equity Fund, Attainment Challenge and will be required to report on these.
- ix New digital devices need to evaluate impact of provision of devices upon attainment and work in class.
- **x** Appointment of 'subject leads' has been undertaken.
- **xi** The appointment of an Executive Business Manager Learning Estates strategy has been approved at a Council meeting.
- **xii** Scottish Government provide lead funding for investment projects and will include.
 - Replacement Beeslack High School
 - Mayfield Campus
 - Refurbishment of Penicuik High School
- xiii It is anticipated that school capacity breaches may occur in Kings Park PS and Newbattle HS in 2023. Additional accommodation temporary or extension with new builds will be provided.

Projects in Planning

- Will depend on council decisions and funding.
 - Bonnyrigg funded by Developer contributions.
 - Gorebridge High School options appraisal to serve catchment area.
 - Shawfair development of a 3 18 campus. Will be looking at being a 'school of excellence.'
 - Newtongrange PS refurbishment
 - Lawfield PS refurbishment and extension

 New Beeslack High School location will be co located within the University of Edinburgh's Easter Bush Campus. It is anticipated that the school roll will be between 1200 – 1600 and will have a dedicated learning space for children with Additional Support Needs (ASN). Architects have confirmed that the current design can increase facilities and the take into account of anticipated increase in population of Loanhead. Beeslack High School HS will be a 'school of excellence' for STEM subjects.

RH (Chairperson) noted that the extent of new development is exciting for local people. He thanked MS for her attendance at the meeting.

- iv During the past year, the Federation had maintained its representation on a wide range of groups including Environmental issues, Care for People, Midlothian Traffic Roads, and Paths, Planning and Community Planning.  Council Officers and in particular that provided by Communities Lifelong Learning and Employability Team members.
