# 5. LOCAL PLACE PLANS – SUPPORT FROM PLANNING TEAM

# i Sharing Data

Council officers have completed a Data Protection Impact Assessment on this matter and data collected from surveys is deemed as low risk for sharing with community bodies preparing a Local Place Plan. Every effort has been put in place to ensure that the Council is not intentionally collecting personal data through the <u>Place Standard Surveys</u> or in-person activities

The Planning team will be able to share survey information supplied directly to them, e.g. through the Council website or at drop in events. The Council will still require the permission of schools and youth groups to share data collected from them with community bodies for Local Place Plan purposes. This would be done through a written data sharing agreement between the Council and school or youth group. This agreement would be secured with the group when they meet with those groups (schools/youth groups).

The Council will ask community bodies that any such data shared with it is used solely for the purposes of a Local Place Plan preparation

# ii Engagement

Local Place Plan regulations require community bodies to demonstrate how they have engaged with the public. The Council will be unable to guarantee that it will have data from children and young people from individual Local Place Plan areas to share

The Council recommend that community bodies also look into ways in which they can engage with children and young people in their local area to compliment any data the Council gathers in support of its Local Development Plan preparation

# v 'Place Standard Surveys'

The team want to know the views of local communities on the areas of Midlothian that they live, work or spend time in. Where we spend our time has an important effect on our lives and our wellbeing. Understanding what is good about a place now, and what could be better, will help us make good decisions and allow us to plan for the right things.

The team has prepared a "Place Standard Survey" to ask for opinions on different aspects of a community:

# Local Development Plan 2 Activity - Place Standard Survey - Midlothian Council -Citizen Space

The survey asks for opinions on:

- Moving Around, Public Transport and Traffic & Parking
- Streets and Spaces
- Natural Spaces, Play and Recreation
- Facilities and Amenities
- Work and the Local Economy
- Housing and Social Contact
- Safety, Care and Maintenance

For each question, participants are asked rate these aspects on a scale from 1 (a lot of room for improvement) to 7 (very little room for improvement). There is also space to write comments in relation to the questions. It is not necessary to answer all of the questions

The results of the survey will help us understand the good things about living in Midlothian and the things that we may be able to improve through the next Local Development Plan. The team will also present the results of the survey in the Evidence Report that will be submitted to the Scottish Government for approval in early 2024

There are three "Place Standard Surveys" specifically for children and young people. These surveys cover similar topics as the above "Place Standard Survey":

Local Development Plan 2 Activity - Children & Young People's Place Standard Survey for 4 - 10 Year Olds - Midlothian Council - Citizen Space Local Development Plan 2 Activity - Children & Young People's Place Standard Survey for 11 - 15 Year Olds - Midlothian Council - Citizen Space Local Development Plan 2 Activity - Children & Young People's Place Standard Survey for 16 - 25 Year Olds - Midlothian Council - Citizen Space

The team is asking Midlothian's organisations and businesses to tell us about their needs and interests relating to Midlothian as a place. We also want to know what information they think we should be considering for the Evidence Report. ### 11. PLANNING

- i RH (Mayfield and Easthouses) encouraged MFCC and Community Council members to review the Planning applications list on a regular basis.
- ii ASK highlighted concerns about the requirements and capacity of schools to accommodate the rise in the number of young people requiring a school place. Many schools are reaching their capacity to accommodate young people in their catchment area.
- iii MW noted that this is having an impact on small schools in rural areas.

# **12. INFRASTRUCTURE**

- i The Orbital Bus consultation closed on Monday 15 May
- ii Members noted that Lothian Buses are making changes to the timetable and bus services in the county.
- iii Members noted that there had been no consultations about the reduction in service provision.
- iv The alteration to service provision is going to have an impact on Midlothian residents
- W MW (Tynewater) highlighted concerns that the area relies on the very limited Border Bus service subsidised by MC - should this subsidy be cut, the area will lose all of its public transport provision and that this may lead to isolation of vulnerable groups and residents relocating to other areas of the county where they would have access to a bus service. However he informed the group that a 'Bus Action Group', supported by Tynewater Community has been formed to challenge potential cuts. BF noted that 'Edinburgh Bus Users Group' may be able to provide some support to the Tynewater group

Action: BF agreed to draft a letter on behalf of MFCC to Lothian Buses drawing attention to the concerns about the changes in service provision and inviting a member of Lothian Buses to join a MFCC meeting at a future date. The letter will circulated before being sent to Lothian Buses.

# **13. ENVIRONMENT**

- ASK highlighted that the Forth River Trust is about to initiate an 'Outfall Safari' project on the River Esk. Information about similar projects can be found here: <u>Outfall Safari | Forth Rivers Trust</u>
- ii SM (Newtongrange) noted that spraying around trees and bins has been undertaken in the area. This was thought to be instead of weeds being strimmed

- iv ASK noted that she had been in contact with Midlothian Council about the administration grants awarded to Community Councils. Clearer guidance about the amount that can be applied for would be helpful.
