

# **NORTH FRODINGHAM PARISH COUNCIL**

## **1. Apologies for Absence**

Councillors Mrs A. Mahl and Mrs A. Melbourne apologised for their absences.

## **2. Approval of Meeting Minutes 12 July 2021**

The minutes were approved.

## **3. Declaration of Interests**

There were no declarations of interest.

## **4. Ward Councillors Update**

East Riding of Yorkshire Council staff are gradually returning to working in the offices, although there is still a mixture of virtual and face-to-face meetings. Discussions are ongoing regarding the combined authorities of Hull and East Yorkshire and they have asked to be included in the pilot scheme for 'County Deals' to gain more power over transport, skills and economic support.

The Parish Council received a complaint regarding the laying of flowers and balloons by the bridge near St Elgin's Church after a recent tragic accident, the complainant was concerned that the view for traffic is being blocked which may result in further accidents.

**Resolved:** Ward Councillors advised that they appreciate this is a very sensitive area and will make enquiries with East Riding of Yorkshire Council who usually act appropriately in such cases.

## **5. Matters Arising**

### **a. The Queen's Platinum Jubilee**

A list of events to take place in June 2022 will be placed on the website.

### **b. Public Space Protection Order (PSPO) Review**

There will be no changes to the orders for North Frodingham which are currently dog exclusion orders for the children's play area (Social Centre) and North Frodingham Primary School.

### **c. Wansford Bridge**

The bridge has recently reopened subject to a temporary 7.5 tonne weight limit. East Riding of Yorkshire Council is considering options including strengthen the bridge which will be subject to sourcing funding and design options will be looked at.

### **d. GDPR**

The draft policy was approved and documents will be published on the website.

## **6. Administration**

To receive updates on:

### **a. Village Improvement Committee**

- A grant has been applied for through the Sandsfield Community Fund for a lawn mower and a noticeboard for the cemetery.
- The Lissett Wind Farm grant has come through and work on the new railing for the cemetery is going ahead.
- Councillor Doyle is to meet with East Riding of Yorkshire Council to discuss the positioning of a mill wheel at the entrance to the village between the foot bridge and the main bridge near St Elgin's Church. The Parish Council approved the payment for cement costs.

### **b. Social Centre**

The Social Centre held its Annual General Meeting in September and Paul Jones will remain as Chairman; Sophie Watson is Secretary and Angela Wilson is Treasurer. The Summer Fayre and Big Birthday Bash were both a success and bookings for more birthday parties are coming in. There will be a Community Bonfire Night on the 5th November 6-8pm. The Cabinet Secretary has confirmed that that the metal railings outside the centre do not belong to East Riding of Yorkshire Council.

### **c. Allotment.**

Councillors are looking at plans and funding options available to create a memorial/reflection garden and allotments.

### **d. Asset inspections**

The majority of assets have now been inspected and there are no major concerns although some areas will be tidied.

### **e. Traffic Survey**

The traffic survey took place on the B1249 Main Street for a week from the 6 September and the Parish Council will be updated with the results. The Community Speedwatch programme has been put on hold while waiting for results of the survey.

## **7. Planning**

### **a. Planning applications**

In order to adhere with deadlines the Parish Council submitted comments on application 21/02298/PLF Land to south of 34 Main Street between meetings\*.

#### **i. 20/03060/STVAR Land north east of Eastfield Farm, Stockbridge Lane, Hutton Cranswick**

Variation of condition 10 (approved plans) of planning permission 19/04321/STPLF: Construction of a solar farm and battery storage facility together with all associated works, equipment and necessary infrastructure.

**Resolved:** The Parish Council has no comments on this application.

#### **ii. 21/3292/Land west of Alderson Mews, Main Street**

Erection of 5 dwellings following outline permission 18/02974/OUT (all matters to be considered).

**Resolved:** The Parish Council objects to this application on the grounds of parking, traffic safety and adequate sewerage\*.

### **b. Planning Decisions**

Permission Granted - 21/01797/PLF Land north east of 49 Main Street.

### **c. Planning Enforcement**

East Riding of Yorkshire Council have confirmed that the outbuilding at 5 Townside Road is Permitted Development and the vans have been removed from the field.

- The footpath into the village from the church is difficult to walk as weeds are growing on the bank/verge taking up the footpath, this will be reported to East Riding of Yorkshire Council.
