4. Ward Councillors Update

5. Matters Arising

a. Public Rights of Way Improvement Plan 2022-2023

East Riding of Yorkshire Council (ERYC) is updating the Rights of Way Improvement Plan (ROWIP) which can be viewed on their website. Councillors will forward any comments to the Clerk.

b. Councillor Vacancies

There are currently several vacancies for new Councillors, advertisements will be placed on the noticeboards and social media.

6. Administration

To receive updates on:

a. Village Improvement Committee

The cemetery gates are being painted and will soon be put in place. The funding for the new lawnmower has been received. The Christmas tree has been removed, thank you to Dan Backhouse. The work on the millstone is continuing. Councillors are researching the Jubilee Fund and it was agreed that an application should be submitted if possible.

b. Social Centre

It has been an expensive month for the Social Centre with payments for a pump for the playground, electricity repairs and a boiler service, there was very little income.

c. Allotments

There were no updates on the allotment.

d. Village Matters

Church Lane Traffic Lights and Bridge Repairs

ERYC advised that the bridge belongs to the Holderness Internal Drainage Board and therefore it cannot be involved in the repairs. The road safety records for the bend shows that the conditions required to justify the introduction of traffic lights at this location have not been met. The Internal Drainage Board stated that it is uncertain when the work on the bridge will be carried out as it is subject to an insurance claim.
