Minutes of the Parish Council Meeting held at 7:30pm on 14 October 2024, at the Village Hall.

Present: Councillors: Chairman M Doyle, A Greaves, R Richardson, D Stead and S Watson.
Community Engagement Manager for Dogger Bank D and Clerk M Rose.

Absent: Councillors: J Syers, N Walker and T Walker.

Public Participation. The Community Engagement Manager for Dogger Bank D attended to discuss the project and answer questions.

1. Apologies for Absence

Councillor J Syers apologised for being unable to attend the meeting.

2. Approval of Minutes

The minutes of the meeting on 9 September 2024 were approved.

3. Declaration of Interests

No interests were declared.

4. Matters for Ward Councillors

East Riding of Yorkshire Council stated that the overgrown footpath on Church Lane is 'under review'.

5. Matters Arising and Correspondence

- a. **Dogger Bank D.** Open consultation will close on 22 October 2024, the Parish Council had no comments for submission.
- b. **The Speed Indicator Device Scheme.** Due to restrictions of the scheme the Parish Council will not be applying for funding at this time.
- c. **Road Safety Issues.** A resident expressed concern over road safety issues in the village, the Parish Council agreed to continue to push these important issues.
- d. **Polling Stations Review.** East Riding of Yorkshire Council are required to review its polling places every five years, as no changes are recommended for North Frodingham comments will not be submitted.

6. Administration

- a. **Village Improvement Working Group.** The Parish Council approved the ordering of solar Christmas tree lights estimated at £40 and approved a quote by Little Wren Services for £160.00 for pruning the plants at Millennium Garden.
- b. **Village Hall Christmas Events.** Councillors are unable to assist with additional events for the Village Hall.
- c. **Village Cross.** Further to enquiries, East Riding of Yorkshire Council made several suggestions to help with preventing damage to the cross, which included using temporary planters or signs, that may include reflective strips. The Parish Council did not consider the proposals to be viable.

7. Planning

Notification of appeal for 24/00088/REFUSE, Land and building south west of 2 Cross Lane.

Outline proposal. Erection of 4 dwellings following demolition of extension to existing dwelling and demolition of existing building, (access and layout to be considered). The Parish Council had no additional comments for submission.

8. Finances

- a. **Monthly Report, Budget Review and Draft Budget for 2025-26.** The report and budget review were approved and bank reconciliation signed. The draft budget will be amended for further discussion at the next meeting. An additional 30 minutes contracted hours for the Clerk was approved, from 1 April 2025.
