### 5. Matters Arising and Correspondence

**Local Audit Reform Consultation.** The government is looking to transform the local audit system, recommendations include bringing as many functions as possible into one body, a new Local Audit Office. #### a. Village Improvement Working Group.

#### b. Memorial Rights.

A draft update of the Cemetery Regulations Policy, which includes a new section to define who will be given the right to erect and inscribe memorials in the absence of exclusive rights being previously granted was approved.

## 9. Councillor's Reports

The puddle on the corner of Main Street near Grange Road was reported to East Riding of Yorkshire Council (ERYC) again, it is now believed to be a problem with the gully and the issue has been passed on to Highway Maintenance Services Team.

ERYC will be asked for compensation towards the extra cost of gritting salt due to the broken drain on Cross Lane, it will also be asked to refill all salt bins in the village.

ERYC will be asked for an assessment of the overall drainage in the village, which is believed to be inadequate as the condition of many roads and footpaths are becoming increasingly worse and more dangerous in wet and freezing weather.

The Village Hall is looking to hold a Festival of Lights and afternoon tea to celebrate the 80<sup>th</sup> anniversary of VE Day.
