1. Apologies for Absence

2. Approval of Minutes

Councillors N Walker and T Walker declared interests in matters relating to the Village Hall.

4. Matters for Ward Councillors

Councillors visited the leak at the waste treatment plant, it was a dry day and no evidence of a leak was present.

The latest Crime Statistics show a significant reduction of crimes reported in the ward.
