Public Participation. No items were raised.

1. Apologies for Absence

There were no apologies.

2. Approval of Minutes

The minutes of the meeting on 10 February 2025 were approved.

3. Declaration of Interests

No interests were declared.

4. Matters for Ward Councillors

East Riding of Yorkshire Council (ERYC) are inviting comments on proposed boundary changes, the changes will mean North Frodingham will be in the East Wolds ward instead of East Coast and Rural. Ward Councillors were asked to investigate a continuing leak at Beeford Treatment Works and offered to carry out a site visit with Parish Councillors.

5. Matters Arising and Correspondence

- a. **Dogger Bank D project refinements.** The proposed cable corridor has been updated and further details will be announced in a consultation summary report and statutory consultation will take place in summer 2025. Councillors A Greaves and S Watson were appointed as delegates for the liaison committee meetings.
- b. Village Hall Hire Agreement. The hire agreement for the rental of rooms was signed, dates of future meetings will remain as the second Monday of the month starting at 7:30pm. With the exception of August.

6. Administration.

a. **Village Improvement Working Group**. To mark the 80th anniversary of VE and VJ Days, the group are arranging a display in the Millennium Garden and placing spot lights near the War Memorial. Application for funding for decorations and items for the Village Hall celebration has been submitted. Authorisation to accept the offer and purchase items was given to the Clerk should the application be successful.

b. **Village Hall.** The Committee has two new members and plans are continuing towards a celebration afternoon to mark the 80th anniversary of VE Day.

7. Planning

- a. **Application**. 25/00468/TCA Main Street Gardens, Main Street. NORTH FRODINGHAM CONSERVATION AREA. Crown reduce a cherry tree (T1) by 2 meters. The Parish Council deferred the decision to the Tree Officer.
- b. **Permission granted.** 24/03753/PLF High Farm, 111 Main Street.

8. Finances

- Concerns were raised regarding youths on cycles with no lights and dark clothing using nuisance and intimidating behaviour. The Neighbourhood Policing Team will be contacted for advice.
- ERYC will be asked how much the Parish Council needs to contribute to the Bus Shelter scheme for a new shelter.
- The loose grate on Main Street opposite the entrance to Eastfield Close will be reported to ERYC
- Commuted Sums will be asked if there is any allocation either currently available or in the pipeline for North Frodingham.
