Minutes of the Parish Council Meeting, 7:30pm on 8 September 2025, in the Village Hall.

Absent: Councillors M Doyle, R Richardson and S Watson.

Public Participation. No items were raised.

1. Apologies for Absence

Councillors M Doyle and R Richardson apologised for being unable to attend the meeting.

2. Approval of Minutes

The minutes of the meeting on 14 July 2025 were approved.

3. Declaration of Interests

Councillors N Walker and T Walker declared interests in matters relating to the Village Hall.

4. Matters for Ward Councillors

No matters were raised.

5. Matters Arising and Correspondence

- a. **Standing Orders Update**. The updated document was approved, changes related to new procurement legislation, and the introduction of gender-neutral pronouns.
- b. Crime Statistics. The bi-annually antisocial behaviour statistics report was read and noted.
- c. **IT Policy.** The proposed document was adopted.
- d. **Reserves Policy.** The proposed document was adopted.
- e. **Tree Inspection Report.** The inspection shows that 3 or 4 trees need felling, mostly due to ash dieback disease, and 2 or 3 trees need maintenance work. Quotes will be sought for the work.
- f. **ERNLLCA AGM.** All Councillors were invited to attend the meeting on Wednesday 24th September, 7pm on Zoom.

6. Administration.

- a. **Village Improvement Working Group.** East Riding of Yorkshire Council (ERYC) has offered 100% funding for a new bus shelter. The Parish Council approved the choice of a wooden shelter, the position of which needs to be approved by a Highways Engineer and then a public consultation period will be held.
- b. **Village Hall.** Bookings are going well, however more volunteers are needed. The Committee has appointed a new Chair and Vice-chair.

7. Planning

ERYC have adopted the Housing Needs Supplementary Planning Document which adds further detail to the policies in the Local Plan Update. - c. **Twilight Bus Donation Request**. The Parish Council awarded a grant of £100 towards the operational cost of the Driffield School Twilight Bus.
- d. **Local Government Pay Agreement.** Local government employee representatives and the trade unions Unison and GMB have agreed a 3.2% pay increase for chief executives and all employees with effect from 1 April 2025, to be back paid as soon as possible.

11. Reports and Updates

- Christmas decorations were discussed and the cost of solar powered projecting lights will be looked in to.
- The condition of the footpath between the village and the Church will be reported to ERYC, again.
- ERYC will be asked for an update on works relating to the broken section of road on the B1249 near Bridge Farm and Church Farm.
- ERYC will be asked to have another look at the loose drain cover on the Main Street, opposite the entrance to Eastfield Close.
