- Main issue is the drainage the area already cannot cope with both surface water and sewerage.
   When it rains heavily the whole area floods and manhole covers have been blown off in the past.
   The drainage needs to be upgraded in the first instance.
- The parish council do not wish to see the development of flats this would make the area too high density.
- The building of a shop is not necessary and the parish council do not believe it could be sustained which would leave the premises boarded up in the future.
