Structure Governance & Management

Constitution

NOSAS 5CIO was granted Charitable status by OSCR on 15 January 2014 and it is governed by the constitution which was approved at its formation and has not been amended.

Appointment of Trustees

The members of the management committee, which normally meets every 2 months, are the charity's trustees. Any member can be appointed as a trustee provided he/she is not an

employee of the society. Trustees are elected at the Annuai General Meeting which is normally held in October. Under the constitution, the number of Trustees should not exceed twenty and not be less than eight. The committee may appoint any member to be a trustee.

This appointment must be approved by the members at the next Annuai General Meeting Trustees can only serve for 6 years and then must have a 1 year break.

Management

The Trustees are responsible for the management of the society.

Objects & Activities

Charitable Purposes

The society is a membership based voluntary group that seeks to encourage people of all ages to learn about and engage with the archaeology of the North of Scotland, to enjoy it, and to protect it for the future. Its purposes are:

- The advancement of education by arranging and supporting projects and events, formal and informal, which enable members and others to learn archaeological methods and associated techniques.
- 2. The advancement of the arts heritage, culture or science by
 - a. undertaking and supporting relevant archaeological projects which add to the public record of our heritage
 - promoting awareness and understanding of our heritage by arranging discussion sessions and exploratory walks, publications, and participating in public events.

Activities

During 2013-14 NOSAS had five committee meetings and one NOSAS SCIO meeting. This last meeting marked the ciosure of NOSAS and the transfer of all the assets and members to NOSAS SCIO.

Despite the transfer of the governance of the Society to the new SCIO there was no substantial change to the character of NOSAS activities carried out during the year.

A programme of winter walks was undertaken around Easter Ross, Inverness and south Sutherland. The Monthly Archaeological Discussion (MAD) nights held at Strathpeffer Community Hail provided a forum for talks from visiting professionals, for example Candy Hatheriey and Steven Birch and our own members. These continue to increase in popularity and are nearly self funding.

The Christmas dinner was held at Coul House with an after dinner walk the following day in Strathconon looking at illicit stills.

Throughout **the winter** the fieldwalking at Tarradale continued. Early in the year several members were involved in a project to survey and draw the remains of the Embo 'Zulu' fishing fleet abandoned on a beach near Little Ferry South in Sutherland. This project was in partnership with SCAPE and other organisations.

(Activities, contd.)

In **early summer** there was a training weekend provided by our members on the West coast at Keppoch where a number of members participated and this included a special evening meal. The weekend was extended to include a walk on the Monday to a remote depopulated settlement with earlier remains. During the summer many members were engaged at various archaeological digs which took place in Highland. Several members have begun surveying some of the hillforts in Highland in line with the National Hillfort Project.

A two-day training event will take place in September near Tomatin, within the Cairngorm National Park, in association with the Royal Commission of Ancient and Historical Monuments of Scotland. Throughout the year members were represented at a wide range of public conferences and events. Reports were issued for 3 completed projects:

- An archaeological survey of the policies of Castle Leod, Strathpeffer
- A report on a project to prepare the kiln at Mulchaich Farm, Ferintosh, Ross-shire for presentation to the public
- A report on a survey of archaeological sites on part of the Corrybrough Estate, near Tomatin, Inverness-shire.

A First Aid course was run for 12 members to Increase their ability to react appropriately to emergencies, particularly when In remote locations.

The NOSAS library has been made more accessible to members using their public library card. It is also accessible to the general public for use within Dingwall library. The committee has made provision for a regular annual purchase budget for new books.

Achievements & Performance

The Committee continues to implement the development plan adopted in 2012. However they are aware of the need to keep the plan up to date and with this in mind a consultation evening was held in March 2014 to investigate the needs and expectations of the membership. To increase input from as many members as possible a questionnaire was subsequently circulated to the members who weren't able to attend this meeting. An updated development plan will be delivered to the membership for approval at the AGM in October.

Our objective of continued skills development through a variety of methods has been achieved. The weekend at Keppoch and the two Tomatin days have developed skills in plane-tabling, sketching and measured off-sets. These weekends also provided an opportunity for members to socialise.

The Highland Archaeology Festival has always been supported by NOSAS and this continues, with events being run by members. These events are open to the general public and therefore disseminate our knowledge and understanding of the archaeology and history of the Highlands. The steady increase in membership is an indication that we are reaching out into the Highlands and providing a facility for the community

The excavation at Mulchaich was completed and is maintained as part of Archaeology Scotland's Adopt-a-Monument scheme. This adoption will help to ensure its stability in the future. The leaflet produced is available to the general public and explains its importance in the history of the area.

A second Adopt-a-Monument scheme, involving cleaning and laying open a Neolithic cairn at Mulbuie on the Black Isle, is nearing completion.

Financial Review

The society has only operated for one month as a SCIO with the assets, liabilities and members of the old non charitable NOSAS being transferred to the SCIO at 1 August 2014.

Our main source of funding will be from members' subscriptions with additional funds from donations, events and grants generally for specific projects.

Expenditure will include the running of events, the costs of projects, the acquisition and maintenance of equipment and the general costs of operating the society.

During the one month period when the society operated as a SCIO the income consisted of a transfer of funds of £12,361 from the old non charitable society, member's subscriptions of £5, book sales of £168 and expenses of £35. This leaves bank balances of £ 12,500.

Reserves Policy

The policy of the Trustees is to maintain sufficient reserves to cover normal annual running costs and have sufficient funds to investigate research and fund future projects. At the end of the period the society has reserves of £12,500.

Plans for Future Periods

The Trustees intend to continue to develop the existing activities of the society and will embrace new projects as they emerge. The society Development Pian 2014, once approved, will be available for viewing on the Society website
