- **5.** Chairman's Report The Chairman, Peter Hall delivered his report for the year 2016-2017. He highlighted the amount of time spent by volunteers on behalf of the Company. Land issues take a lot of Board time. He was pleased to report that an offer of £180k had been made to purchase the Garage site with £161.500 sourced from funding from the Scottish Land Fund. A working group will be formed from volunteers to have input into the Garage project once the purchase has been completed. Office space is being sought. Policy and Procedures are being prepared. There is continued dialogue with the Crown Estate who own one third of the Findhorn Bay. Directors had attended seminars and visited other community groups.
