Kettering Borough Council 14 Day Re-notification: Planning Application KET/2017/0228

Applicant: S Guinness

Details of Application:

Conversion of 1no. agricultural barn to B1 office including the installation of mezzanine, glazed screen, roof lights and windows; and 1no. agricultural barn to residential annex including private office with associated works including 4no dormer openings, windows and external staircase. Creation of 8.no car parking spaces at The Hermitage, Desborough Road, Brampton Ash, LE16 8GP

council that a requirement for the use of the proposed annex to be tied to the main residence only would be made as a condition of planning approval. (*Email from A Shepherdson to Brampton Ash parish council 4/07/2017*). Further, the Planning Statement & Transport Statement submitted by the applicant states that '.....Barn 1 will be purely for the private use of the house.' (*Planning Statement & Transport Statement 16/03/2017 page 7, para 2*). This clarifies the parish council's previous query as to whether the premises were intended for private use, commercial use or a mix of both.

Councillors questioned the need to provide 8 no. car parking spaces, particularly as current planning guidance indicates that 5no. should be provided (see Planning Statement & Transport Statement page 7, para 5). It was noted that, of the originally proposed 13 spaces, 2no had been removed for access to waste bins & etc and 1no. space had been re-designated for cycle/motorcycle use: this space remained large enough, however, to use as for car parking. Given that there are already 22no. existing car parking spaces on the site in its entirety, councillors believed the provision of a further 8no. spaces to be excessive.

In summary, whilst councillors were reassured to note that the conversion of Barn 1 was to be purely for residential use they considered that this factor supports the provision of a maximum of 6no. parking spaces for cars and cycles/motor cycles. Brampton Ash parish council therefore unanimously reiterates its view, as recorded in the minutes 21 April 2017, that the provision of 6no. parking spaces is a more reasonable requirement.
