	Councillors viewed the plans and discussed the proposal. It was unanimously agreed	
	that the parish council would forward the following comments to Kettering Borough	
	Council:-	
	Brampton Ash Parish Council does not oppose the application but strongly urges	
	that the following points to be taken into account prior to the granting of planning	
	permission:	
	1 Access Date and 2m wide access two de	
	1. Access: Proposed 3m wide access track	
	Access from this track is directly onto Hermitage Road. The parish council has campaigned tirelessly on road safety issues in the village where, far from being a quiet	
	country lane, Hermitage Road is very frequently used as a 'rat run' by traffic travelling	
	between the A427 and the A6, in either direction. It has particularly been observed that non-local traffic leaving the A427 very often accelerates at the point immediately prior	
	to the proposed access, despite visibility being obscured by a bend in the road, by trees and by the telephone box. In the interests of road safety, the parish council requests	
	therefore that the gateway to the track should be set back from the road, sufficiently as	
	to provide a safe pull-in for vehicles accessing the track, especially when considering the	
	size of modern horse transport vehicles.

2. Impact on Neighbouring Property

The parish council requests that every possible effort be made to minimise any adverse effect on the occupants of immediately adjacent neighbouring properties who are most likely to be impacted by the development. For example:

- a) Many of the trees within the site are known to be laurel trees which would presumably need to be removed due to their toxicity to horses. In the event of their removal, it is requested that alternative, sympathetic visual screening be provided for the benefit of adjacent, neighbouring properties, where it is mutually deemed appropriate to do so.
- b) The plans do not show a location for the storage/disposal of horse-muck. Whilst it is logistically unlikely that horse-muck, with its associated smell and attraction for flies and, particularly, horse flies, will be stored or disposed of close to any adjacent neighbouring property, the parish council seeks an assurance on the matter.
- c) The parish council seeks an assurance that stringent vermin control will be exercised, so as to minimise any nuisance to adjacent neighbouring property.

3. Non-Commercial Use

It is noted that the application is for a development ancillary to Grange Farm. The parish council requests that the granting of planning permission be conditional on the site being for personal use only, with no commercial use permitted.

4. Disparity in Plan Presentation

Councillors noted that the location plan provided by the applicant was somewhat misleading because the proposed buildings, as shown on the plan, do not accord with the scale legend shown on the bottom left of the said plan.

The clerk would inform Kettering Borough Council of the parish council's response.
