Proposal: Change of use of holiday accommodation to permanent dwelling

(amended plan for parking provision received 22/03/2018)

Location: Leighhurst, The Street, Draycott, Cheddar BS27 3TH

Applicant: Mrs Helen Dance Appl. Type: Full Application

Cllr Gladman did not take part in determining this application as he had declared interests.

The application was discussed, topics included: the previous Parish Council decision; consultee and public comments; comments received from the applicant, these were circulated prior to the meeting and noted; the glazing of the window and the previous planning condition; turning and parking at the property; turning for larger vehicles such as family cars; parking on The Street and access; ownership of the property. Cllr Haskins proposed that the Council object to the application on the basis that the Council continue to have concerns about the parking. Although there is an increase in the number of spaces the Council do not consider that turning and parking is sufficient to prevent an impact on The Street, particularly for family/larger cars. The Council notes the compromise on the matter of the obscured window as satisfactory; and reiterate that should Mendip District Council be minded to approve the application it should be requested that: the site should remain in perpetuity in one ownership as per the deeds; and permitted development rights at the property should be removed to ensure that no further structures compromise the limited parking and turning space. Cllr Marsh Seconded. Agreed.
