**Resolution:** Cllr Ward proposed recommending refusal, stating that the Council would be minded to recommend approval if the following were adopted as conditions: The obscure windows should be non-opening or fixed; the unspecified stone finish should be Draycott stone; the roof lights should be fitted with smart glass or automatically closing blinds connected to the electric light switches. Cllr Dudden seconded. Agreed.

**26/20 Correspondence:** The Mendip Local Plan examination - ED27 Inspector's Letter was noted.

**27/20** Members discussed recent further damage of the stream bank on Scaddens Lane footpath. The Clerk is to contact Bristol Water again and inform them of the increasingly dangerous condition of the path.

**28/20** District Cllr Wyke updated members on District matters including: grants for village halls; coronavirus figures in Somerset; local hospitals staged plan to resume other surgeries such as electoral surgery and oncology; Nightingale hospitals and excess provision that has not been needed; encouragement to use the 'one number' **0300 790 6275** for any District and County coronavirus enquiries; Mendip District Council helping business through grants and now moving towards helping the self-employed.

District Cllr Wyke invited comments on an agricultural determination application and provision for water run-off was raised.
