It was agreed that because Mr Alasdair Bennet and Mrs. Rhona Elder from East Kintyre Renewable Energy Group (EKREG) had come to give us a small presentation that we would do this first and then have our meeting. We also had members from the Laggan Community Council visit to hear the presentation

Mr. Bennett then gave us an update of the community shared ownership of wind farms. The benefit at present to communities from

The output from Tangy II is approximately 19mw of power from 120m tall towers that increased to 37mw power from 130m tall towers and the hope is that they will get permission to increase the towers to 150m tall and by doing so increase capacity to 80mw of power. The government's recommended community benefit should be £5k per mw.

Mr Bennett then advised that his group felt there was a greater possibility of increased funding to communities and had been talking to companies asking if communities could look at a share for the good of the communities and he felt that if all the Kintyre communities could speak with one voice we would be a much stronger force to work with. There followed a question and answer session.

The committee at the end of his presentation agreed to discuss our feelings and Margaret would get back to him. Mr. Bennett and the rest of the visitors then took their leave.

Tree planting would obviously soak up water from both of these denying the households water. Margaret to write to Mark Simpson and Margaret Bateman will go and speak to the new owners at Glenburn. The concern is that this land will be used eventually for a wind farm.
